# 2021 Annual Report of Sexual Assault Data Findings and Corrective Actions

#### 1 Introduction

The Prince William-Manassas Regional Detention Center (PWMRADC) has a zero-tolerance policy toward sexual abuse and sexual harassment in our facilities. The Adult Detention Center will comply and enforce all federal, state and local laws pertaining to sexual abuse. The agency is committed to the prevention, detection, response and investigation of sexual misconduct.

This collection of information is compared to previous years' data and utilized by the Department's Prison Rape Elimination Act Coordinators to identify potential issues or areas of concern and formulate corrective responses to reduce victimization of sexual abuse.

The data collected is also available for use by the US Department of Justice for completion of the Survey of Sexual Violence (SSV).

This report has been approved by the Superintendent and all data in this report will be maintained on the website for at least ten years after the date of the initial collection.

### II. Prevention

All allegations will be fully investigated, which includes those of sexual abuse and sexual harassment, by the Internal Affairs Division of the Prince William-Manassas Region Adult Detention Center and or the Prince William County Police Department.

In compliance with the Prison Rape Elimination Act (PREA) standards, we have implemented several procedures for the prompt reporting of allegations of alleged sexual offences.

Inmates may report instances of non-consensual sexual acts, abusive sexual contacts, staff sexual misconduct, or staff sexual harassment, to any staff member, volunteer or contact worker or third party. The inmate may do the verbally, or in writing. Inmates have the ability to use grievances, request forms and confidential reporting hotlines to report any instances of sexual abuse and rape within the jail. All efforts will be made to ensure the confidentiality of the reporting inmate.

#### III. Education

The agency has taken a pro-active stance in educating all visitors, contractors, and vendors that are in contact with the inmate population. All Adult Detention Center staff have been trained in prevention, detection and investigation of sexual related incidents. The inmates are also educated to their rights to be free of any form of sexual abuse. Any substantiated instances of sexual abuse relating to inmate, staff/volunteer/vendor/contractor to inmate will be prosecuted to the fullest extent of the law as well as any false allegations of sexual abuse.

#### IV. Definitions

Rape or Sexual Assault: (a) the carnal knowledge, oral sodomy, sexual assault with an object, or sexual fondling of a person, forcibly or against that person's will; (b) the carnal knowledge, oral sodomy, sexual assault with an object, or sexual fondling of a person not forcible or against that person's will, where the victim is incapable of giving consent because of his or her youth or his or her temporary or permanent mental or physical incapacity; or (c) the carnal knowledge, oral sodomy, sexual assault with an object, or sexual fondling of a person achieved through the exploitation of the fear or threat of physical violence or bodily injury.

In accordance with PREA, all investigations are assigned one of three determinations:

Substantiated: an allegation which was investigated and determined to have occurred.

Unfounded: an allegation which was investigated and determined not to have occurred.

<u>Unsubstantiated</u>: an allegation which produced insufficient evidence to make a final determination of a substantiated or unfounded claim.

### V. Data

2021

Data in this report reflects calendar year 2021: January 1, 2021 to December 31, 2021.


On December 31, 2021 the daily population was 470.

The average daily population for the Prince William-Manassas Regional ADC in 2021 was 544.

There were 6,369 Commitments to the Prince William-Manassas Regional ADC in 2021.

Corrective measures that were taken in 2021 consisted of:

No corrective measures were necessary. There were no substantiated or unsubstantiated allegations. Staff followed policy and procedures. While there were no corrective actions taken, there were mulitple upgrades made throughout the facility. These include opening Phase II in June and occupying in September. This expansion added 204 additional beds, including those in a fully functional Mental Health unit. The security camera system also received and upgrade in the Main and Central buildings, adding cameras and increasing storage space and bandwidth.
