Mike (Sully) Sullivan NOVA Dis Golf Association- Gave an Overview of Structure of Organization.

- Disc Golf or Frisbee Golf is played much like golf. Over 400 members an in 2021 over 275 additional members
- Forest Green has been approved by the BOCS.
- Within 3-5 year an event to bring in premier PDGA sanctions.
- Forest Green is a great contrast with more open space than Lake Ridge: as well as a great view of the Marine Museum.
- Objective is to continue opportunities at Lake Ridge Dis Golf & forthcoming course at Forest Green.
 Have layouts for all levels of Dis Golf.

Questions:

Erica Tredinnick asked will there be enough parking space. Mike Sullivan stated that parking space will be needed.

Seth asked Mr. Sullivan to address the users/safety concern. Mike Sullivan will investigate any conflicts/safety issues for building a course that it doesn't fun parallel to putting someone into danger. Space will be made to accommodate users, and more if the partner expanded the trails at Locust Shade Park.

Seth/Brodie asked when will the construction of new Disc Golf be completed/Timeline? Mr. Sullivan- 1st phase, clear fairways, underbrush, install baskets, level & graved for safety. Signage and host club events. Partnership, create budget and maintain club. Finally, organize tournaments and expand parking.

Brodie asked timeline for Forest Green for course completion. Mr. Sullivan stated as soon as weather permits; by March 2022. PDGA Calendar is scheduled for June 4, 2022, depending on the weather and budget.

Jane Beyer asked what is the cost to the Parks & Recreation Department? Mr. Sullivan states its public funded \$75,000 for construction and additional parking. MOU (2021)
