Incidents

Murder/Suicide Investigation – On January 14 at 6:09PM, officers responded to a residence located in the 18300 block of Cabin Rd. in Triangle (22172) to investigate a death. When officers arrived at the home, they located two individuals, a 42-year-old man and a 30-year-old woman, inside the residence suffering from gunshot wounds. The preliminary investigation has revealed the two deceased were located by family members who had received concerning texts indicating the two were having an argument. At this time investigators believe the altercation escalated between the two parties who are husband and wife. During the argument, the husband, identified as Nicholas Allen **SMITH WITHROW**, shot his wife, Brittnee Yvonne **POSEY**, before shooting himself. Both were pronounced dead at the scene. A firearm was recovered on scene by officers. A three-year-old girl was inside the residence at the time and was unharmed. The child was released to the custody of family members.

The deceased were identified as Nicholas Allen **SMITH WITHROW**, 42, and Brittnee Yvonne **POSEY**, 30, both of Triangle

Animal Cruelty – On January 13 at 8:30AM, officers responded to the 1500 block of Cherry Hill Rd. in Dumfries (22026) to investigate a dog that was located with an injury consistent with being struck with a projectile. A resident located the dog suffering from the injury in the area and contacted police. The dog, an American Bully, 1-3 years on age, red/tan and white in color, was transported to an emergency veterinarian. The dog has received medical care and is resting comfortably at this time. PWC Animal Services is seeking assistance from the public on identifying the dog and information about the events leading up to the dog being located this morning. Reckless Handling of a Firearm – On January 12 at 11:03AM, officers responded to the Longview Apartments located in the 13700 block of Lynn St. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed a resident of the complex, identified as the accused, retrieved a firearm from his vehicle and brandished it towards a maintenance worker who was in the parking lot. The parties eventually separated. At one point, the accused fired multiple rounds into the air before being detained without incident by arriving officers. No injuries or property damage were reported. Following the investigation, the accused, identified as Deandrae Ladale **SPRADLEY**, was arrested.

During the encounter, the accused grabbed the victim's neck and struck her before the parties separated. Minor injuries were reported. Following the investigation, the accused, identified as Quinton Jaquille **THOMAS**, was arrested.

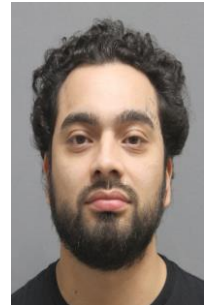

Strangulation | Domestic Related – On January 11 at 11:02PM, officers responded to The Crossings at Summerland Apartments located in the 13700 block of Keelingwood Cl. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed, the victim, a 14-year-old male juvenile, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing his neck. The parties eventually separated, and the accused fled the apartment. While investigating the incident, the accused returned to the apartment, and was detained without incident. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Alvaro Jasmany **TOLEDO-GARCIA**, was arrested.

Assault & Battery on a Corrections Officer – On January 13 at 5:56PM, officers responded to the Prince William-Manassas Regional Adult Detention Center (ADC) located at 9320 Lee Ave. in Manassas (20110) to investigate an assault. The investigation revealed a corrections officer was assisting an inmate of the facility, identified as the accused, when the inmate grabbed the officer's arm and pulled their arm into the cell. The officer was able to separate from the accused and sustained minor injuries to their hand. Following the investigation, the accused, identified as Jamal Donniel **JAMES**, was charged.
