

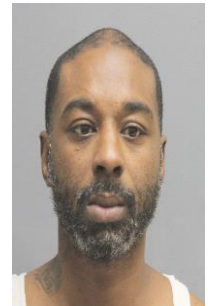


DAILY INCIDENT REPORT

Updates

Aggravated Malicious Wounding *ARREST – On February 8, 2024, the suspect sought in connection to the shooting that was reported to have occurred outside of a residence located in the 14500 block of Earham Ct. in Woodbridge (22193) on October 16, 2023, was arrested. The accused, identified as Michael Carlos **DUNCAN**, was located and taken into custody by Montgomery County police.

Shooting Investigation *SUSPECT IDENTIFIED [Previously Released] – On October 26, detectives identified the suspect sought in connection to the shooting that was reported to have occurred outside of a residence located in the 14500 block of Earham Ct. in Woodbridge (22193) on October 16. While investigating the incident, detectives identified the suspect as Michael Carlos **DUNCAN**, and following the investigation, obtained warrants for his arrest. Attempts to locate the accused have been unsuccessful.

Shooting Investigation [Previously Released] – On October 16 at 7:13PM, officers responded to a residence located in the 14500 block of Earham Ct in Woodbridge (22193) to investigate a shooting. The investigation revealed the victim, a 39-year-old man, was speaking to the occupants of a white Kia Soul in front of the residence, when an altercation ensued. During the encounter, a male passenger in the vehicle fired a handgun towards the victim, striking him once in the lower body. The victim retreated to the home and fired his own weapon multiple towards the vehicle. The female driver of the vehicle was known to the victim from a previous relationship. The victim was treated at an area hospital for his non-life threatening injury. No other injuries or property damage were reported. **This incident was not random.** Detectives are actively following-up on leads regarding the identity of the shooter. The investigation continues.

Officer-Involved Shooting Investigation - On February 13 at 3:23PM, officers responded to an apprenticeship training center located at 7016 Infantry Ridge Rd in Manassas (20109) for an active violence incident of a stabbing-in-progress. Initial information received indicated two victims, both adult men, had been stabbed and that the suspect was armed with a knife. Within minutes, the first responding officers arrived on scene and approached the building where they encountered the presumed suspect at the entrance door. Officers instantly engaged the suspect who was armed with a knife. As the officers issued commands to the suspect to drop the knife, the suspect moved towards the officers. Two uniformed police officers opened fire from their department-issued handguns, striking the suspect. As officers were assessing the suspect's condition, additional officers searched the building for victims. Preliminary information indicates that the initial stabbing occurred in a classroom within the center where the suspect and at least one of the victims were present along with several other students. For reasons still under investigation, the suspect approached the victim, pulled a knife from a backpack, and began stabbing the victim multiple times. Those present inside the room dispersed as the suspect continued his assault on the victim. At one point, the suspect exited the classroom where he encountered and stabbed a second victim in another classroom inside the building. The initial stabbing victim collapsed inside the classroom where the altercation began, and the second victim exited the building and collapsed in the parking lot. Both victims were transported to area hospitals where one of the men died from his injuries. The surviving victim remains hospitalized in critical condition. The suspect was pronounced dead on scene. The investigation into the incident continues to be led by the Critical Incident Response Team (CIRT). Additional details will be released as more information becomes available. Both officers involved in the shooting were placed on routine paid administrative leave pending the outcome of the investigation. Anyone who may have witnessed the incident or has further information, is asked to contact police. The investigation continues.

Identified:

The suspect was identified as Philip Austin **BRANT**, 26 of Woodbridge

The deceased victim in the stabbing was identified as Elijah Islam **SAFADI**, 23, of Manassas

The surviving victim in the stabbing was identified as a **23-year-old man** of Fairfax

Officers Involved:

The officers involved had 5 years and 1.5 years of service, both assigned to uniformed patrol operations

Shooting Investigation – On February 13 at 5:01PM, officers responded to the 15300 block of Gatehouse Ter. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed two men were physically fighting when one of the men brandished a firearm and fired multiple rounds striking the other man. Both men fled the area prior to police arriving on scene. While investigating the incident, officers were informed a 21-year-old man was at an area hospital receiving treatment for non-life threatening gunshot wounds. The man refused to cooperate further with detectives regarding the incident. No additional injuries or property damage were reported. While checking the area, shell casings were located. **Anyone with information that could aid investigators in this investigation is asked to contact police.**

Armed Robbery – On February 10 at 1:48PM, officers responded to investigate a robbery that was reported to have occurred in the area of Dulcinea Pl. and Oakwood Dr. in Woodbridge (22192) on February 9 at approximately 6:00PM. The investigation revealed the victim, a 19-year-old man, was sitting inside his vehicle when three unknown men approached brandishing firearms. One of the suspects then entered the victim's vehicle and physically struck the victim with a firearm before demanding his property. The suspects took marijuana before fleeing the area on foot. Minor injuries were reported.

Suspect Descriptions:

A black male, approximately 20 years old, 6'0", 175lbs., with brown eyes, some facial hair
Last seen wearing a black ski-style mask, a black zip-up sweatshirt, and black pants

A black male, approximately 21 years old, 6'0", 170lbs., with black braided hair, brown eyes, and a full goatee
Last seen wearing a brown hooded sweatshirt with a white design, and dark-colored pants

A black male, approximately 18 years old, 5'7", 150lbs., with short curly black hair, and brown eyes
Last seen wearing a black zip-up hooded sweatshirt and black jeans

Strong-Arm Robbery – On February 13, officers responded to investigate a robbery that was reported to have occurred at the ABC Store located at 4255 Cheshire Station Plz. in Woodbridge (22193) at approximately 3:30PM on February 11. The investigation revealed an employee approached a male patron to offer assistance. During the encounter, the man made threats before shoving the employee with his shoulder and walking out of the store with unpaid merchandise. No injuries were reported. The suspect was described as a black male, with medium build, wearing a black ski-style mask and all black-colored clothing.

Arrests

Sexual Assault Investigation - On February 9, 2024, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence located in the 2500 block of Tree House Dr. in Woodbridge (22192) on December 12, 2023. The investigation revealed the victim, an adult female, was sexually assaulted by her employer, identified as the accused, while the two were at a residence in the above area. The parties separated and the victim later reported the incident prompting the police investigation. Following the investigation, detectives obtained arrest warrants for the accused, identified as Edward **GARRETT**, who was located and taken into custody on February 9, by Fairfax County police.

Threats to Bomb - On February 12 at 11:28AM, officers responded to NOVEC located at 10432 Balls Ford Rd. in Manassas (20109) to investigate a phone threat. The investigation revealed during the course of the phone conversation, the caller, later identified as the accused, became upset and threatened to bomb the building. While investigating the incident, officers identified the accused and determined there was no active threat. Following the investigation, officers obtained arrest warrants for the accused, identified as Damien Michael **BROCKWAY**, who was taken into custody the following day without incident.

Impersonating Law Enforcement | Residential Burglary – On February 13 at 9:29PM, officers responded to a residence located in the 3600 block of Cebu Island Ct. in Woodbridge (22192) to investigate a burglary. The investigation revealed the homeowner returned to their residence where an unknown woman, later identified as the accused, was observed inside the home. Officers made contact with the accused inside the residence where she was detained without incident. While investigating the incident, the accused initially identified herself as law enforcement to the officers which was determined to be false information. The accused entered the home through an unsecured window. Following the investigation, the accused, identified as Genie **RHINEHART**, was arrested.
