Arrests

Strangulation (Domestic Related) – On May 22 at 7:43AM, officers responded to investigate multiple domestic disputes that were reported to have occurred at the Riverside Station Apartments located in the 14100 block of Big Crest Ln. in Woodbridge (22191) between March 19 and May 14. The investigation revealed during the above timeframe, the victim, a 25-year-old woman, and an acquaintance, identified as the accused, were involved in multiple verbal altercations that escalated. During the encounters, the victim was assaulted, and in three of the incidents the accused grabbed
