Incidents

Felony Child Abuse – On June 4, 2024, detectives concluded an investigation into the neglect of a 19-month-old boy after police had responded to a residence located in the 4300 block of Granby Rd. in Woodbridge (22193) on January 22, 2023. The child was found unresponsive by fire & rescue services and subsequently transported to an area hospital where he was pronounced deceased. During the course of the investigation, an autopsy was completed which showed signs of suspected abuse by the child's parents, identified as the two accused. The child's cause of death has not been determined by the Medical Examiner's Office. On June 4, 2024, following the investigation and upon consultation with the Commonwealth's Attorney's Office, detectives obtained arrest warrants for both accused, identified as Jakeline **SANCHEZ** and Richard Osmin **ASCENCIO**. Attempts to locate the two accused have been unsuccessful.



Malicious Wounding – On June 6 at 3:40PM, officers responded to investigate an assault that was reported to have occurred in the 17100 block of Dumfries Rd. in Dumfries (22025) on May 27. The investigation revealed the victim, a 48-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. Attempted Malicious Wounding | Felony Hit & Run - On June 3 at 7:36AM, officers responded to the intersection of Dumfries Rd. and Prince William Pkwy. in Manassas (20112) to investigate a hit and run crash. The investigation revealed the 32-year-old male driver of a 2009 Toyota Corolla was traveling northbound on Dumfries Rd. when the driver of a 2001 Lincoln Town Car, identified as the accused, attempted to turn left onto Dumfries Rd. from Brentsville Rd. in front of the Toyota. Upon entering the intersection, the Lincoln struck the Toyota before driving out of the area. A Good Samaritan followed the Lincoln to



the intersection of Dumfries Rd. and Old Dominion Dr. where an altercation between the two parties ensued. During the encounter, the accused attempted to strike the 53-year-old Good Samaritan with his vehicle before physically striking him. The parties eventually separated and left the scene. No injuries were reported.
