**Strong-Arm Robbery \*ARREST** - On June 6, the suspect sought in connection to the robbery that was reported to have occurred in the 3300 block of Cape May Ct. in Dumfries (22026) on April 26, was arrested. During the investigation, officers identified the suspect and following the investigation, obtained warrants for his arrest. On June 6, the suspect, identified as Quinton Frederick **WASHINGTON**, was located and taken into custody in Stafford County.

**Strong-Arm Robbery [Previously Released]** - On April 26 at 6:49PM, officers responded to the 3300 block of Cape May Ct. in Dumfries (22026) to investigate a robbery. The investigation revealed the victim, a 32-year-old man, arranged to sell a computer and cell phone to an unknown individual via Offer Up. Before the transaction was completed, the suspect, who was holding the devices, pushed the victim and ran from the area. Minor injuries were reported. The suspect was described as a black male, approximately 6'0', wearing all dark-colored clothing and white shoes.

## Incidents

**Reckless Handling of a Firearm** – On June 10 at 6:16PM, officers responded to the area of Neabsco Beach Way and Daniel K. Ludwig Dr. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple shots were heard by a walking trail near the creek. Shell casings were located near a park bench facing the water. No injuries or property damage were reported.

**Commercial Burglary** – On June 11 at 3:54AM, officers responded to A1 Cycling located at 12383 Dillingham Sq. in Woodbridge (22192) to investigate a burglary. Video surveillance revealed at approximately 3:33AM, an unknown man smashed the front glass door to gain entry into the business. The suspect then took a bicycle with him when he exited through the same front door and left the area prior to police arrival. A police K-9 searched the area for the suspect who was not located.

**Residential Burglary** – On June 8 at 7:07PM, officers responded to a residence located in the 8200 block of Heritage Crossing Ct. in Manassas (20109) to investigate a burglary. The investigation revealed sometime between 3:30PM and 4:30PM, entry was made into the lower level of the home through an unsecured sliding door. Personal documents and an undisclosed amount of money were reported missing.

**Residential Burglary** – On June 8 at 5:53PM, officers responded to investigate a burglary that was reported to have occurred at a residence located in the 8300 block of Scotland Lp. in Manassas (20109) sometime between 7:00PM on June 6 and 9:00AM on June 7. The investigation revealed sometime during the above timeframe, the attached garage door was open and multiple power tools were taken from inside the garage. No entry was made into the home.

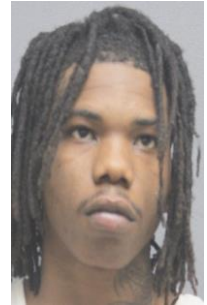

## Arrests

**Armed Robbery** – On June 10 at 12:04AM, officers responded to the Woodbridge Station Apartments located in the 1400 block of Ranger Lp. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 21-year-old woman, arranged to purchase marijuana from an acquaintance, identified as the accused, in the parking lot of the above area. While the victim was outside of the vehicle and near the apartment building, the accused bypassed the victim and ran towards the vehicle. The accused demanded the female occupants, who were between the ages of 17-23, get out of the vehicle while brandishing a firearm towards them. When one of the occupants began driving the vehicle out of the area, the accused smashed a rear passenger window with the firearm. The accused then ran over to the victim and grabbed her arm. As the victim was attempting to contact emergency services, the accused forcefully took the victim's phone. The victim reported minor injuries. While investigating the incident, officers received information that the accused, identified as Dorian Hugh **WILHOIT**, went to the police station where, following the investigation, he was arrested.



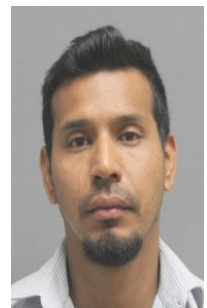

**Strangulation (Domestic Related)** – On June 10 at 12:45AM, officers responded to the Prospect Cove Condos located in the 14100 block of Cuddy Lp. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 32-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck and struck her multiple times before leaving the apartment. The victim reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Rody Alonso **RAMOS MONTALBO**, who was taken into custody later that day without incident.

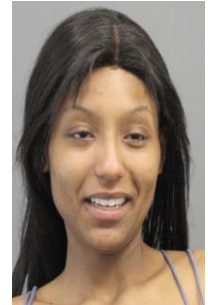

**Assault & Battery on a Law Enforcement Officer [LEO]** – On June 11 at 2:09AM, officers responded to the Red Carpet Inn located at 17005 Dumfries Rd. in Dumfries (22025) to investigate an assault. The investigation revealed a female patron, later identified as the accused, and an employee were involved in a verbal altercation that escalated. During the encounter, the accused refused to leave the property and struck the 53-year-old employee before attempting to stab him with scissors. The accused then smashed the glass front door of the hotel before walking outside. Responding officers located the accused inside a nearby business and when they attempted to detain her she actively resisted. During the encounter the accused bit an officer before being detained without further incident. Minor injuries were reported by both the manager and the officer. Following the investigation, the accused, identified as Ashja Elaine **WAKEFIELD**, was arrested.
