Incidents

Malicious Wounding | Strangulation – On June 15 at 2:54AM, officers responded to the 13700 block of Smoketown Rd. in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 31-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck before throwing her to the ground where he struck and kicked her multiple times. At one point during the altercation, the accused went into the victim's purse and took her phone before continuing the assault. When responding officers attempted to make contact with the accused, he ran from the area. The victim was treated on scene for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Octavious **HODGES**. Attempts to locate the accused have been unsuccessful.

The investigation revealed the victim, a 37-year-old man, was approached by a group of men who held him down while they took his cash app card. No injuries were reported, and no suspect descriptions were provided to the officers.

Strong-Arm Robbery – On June 15 at 10:52AM, officers responded to Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 42-year-old woman, was inside the mall when she was approached by three men. After a brief verbal encounter, the suspects demanded the victim remove money from an ATM. One of the suspects followed the victim to the ATM where she withdrew the money. When the victim attempted to leave, all three suspects physically blocked her until she gave them the money. The suspects then left the area in two separate vehicles and the victim contacted the police. No injuries were reported.

A black male, with facial hair, wearing a black hat, a white shirt, gray jeans, and black/white/red Jordan shoes

A black male with a short afro-style haircut, facial hair, and wearing all-black clothing

A black male with facial hair and wearing a colorful jacket

Residential Burglary – On June 13 at 9:34PM, officers responded to a residence located in the 13400 block of Princedale Dr. in Woodbridge (22193) to investigate a burglary. The investigation revealed entry was forced into an attached garage sometime between June 5 and June 13. Officers determined no entry was made into the residence and no property was reported missing.

Strangulation (Domestic Related) – On June 14 at 11:14PM, officers responded to a residence located in the 12500 block of Oakwood Dr. in Woodbridge (22192) to investigate a fight. The investigation revealed the victim, a 34-year-old woman, intervened to separate a physical altercation between an acquaintance and a family member, identified as the accused. During the encounter, the accused struck the victim before grabbing her neck. Eventually, the parties separated and remained at the residence. The victim reported minor injuries. Following the investigation, the accused, identified as Edwin Armando **JIMENEZ ANDRES**, was arrested.

Malicious Wounding – On June 14 at 4:56PM, officers responded to the 7400 block of Old Centreville Rd. in Manassas (20111) to investigate a stabbing. The investigation revealed the victim, a 30-year-old man, and another man, later identified as the accused, were involved in a verbal altercation that escalated. At one point during the encounter, the accused cut the victim's arm with a knife before the parties separated. The victim was treated at an area hospital for non-life threatening injuries. While investigating the incident, officers were informed the accused also went to the hospital for treatment of minor injuries. Following the investigation, the accused, identified as Tazwell **BLAKENBAKER**, was arrested.

Responding officers located the accused a short distance away where he was detained without incident. When officers attempted to assist the accused into a police vehicle, he actively resisted and spat on an officer. The accused was found in possession of an unpaid item from the store and a concealed knife. No injuries were reported. Following the investigation, the accused, identified as Jarelle Rashod **LITTLES**, was arrested.

The investigation revealed the accused concealed items before walking towards the exit. When a store employee confronted the accused, he struck the employee with the bag and left the store. Officers located the accused a short distance away. When officers attempted to make contact with the accused, he fled from officers. After a short foot pursuit, the accused was detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Leondre **BARFIELD**, was arrested.
