Incidents

Homicide Investigation – On June 18 at 12:44AM, officers responded to the Misty Ridge Apartments located in the 15000 block of Lost Canyon Ct in Woodbridge (22191) to investigate a shooting. Responding officers located a 17-year-old male juvenile in an outdoor stairwell suffering from gunshot wounds. Officers provided aid to the juvenile who was transported to an area hospital where he later died. The investigation revealed the suspect had fled on foot after the shooting. A police K-9 and Fairfax County police helicopter searched the area for the suspect who was not located. An apartment in the complex was also struck during the encounter. No other injuries or property damage were reported. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who has information to assist in the investigation. **Preliminarily, this incident does not appear to be random.** Due to the age of the deceased, their identity will not be disclosed by law enforcement at this time. More information will be released as it becomes available. The investigation continues.

Aggravated Assault – On June 17 at 8:09PM, officers responded to the 2900 block of Dale Blvd. in Woodbridge (22193) to investigate an assault. The investigation revealed the victim, a 45-year-old man, was walking in the above area when he was struck multiple times by two men which caused him to fall to the ground and temporarily lose consciousness. When the victim woke, the suspects had left the area. The victim was treated at an area hospital for non-life threatening injuries. The suspects were only described as black males.

Malicious Wounding – On June 16 at 10:38AM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 3000 block of Antrim Cl. in Dumfries (22025) on June 15 around 10:45PM. The investigation revealed the victim, a 34-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck, kicked, and bit the victim before grabbing her neck. The accused left the residence and took the victim's phone, preventing her from calling the police. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Michael **NELSON**. Attempts to locate the accused have been unsuccessful.

Attempted Commercial Burglary – On June 17 at 12:20PM, officers responded to investigate an attempted burglary that was reported to have occurred at the H&R Block located at 7775 Sudley Rd. in Manassas (20109) sometime between 5:00PM on June 14 and 10:00AM on June 17. The investigation revealed both the front door and a front window appeared to have been tampered with. No entry was made into the business, and no property was reported missing.

Arrests

Attempted Malicious Wounding (Domestic Related) – On June 16 at 8:57PM, officers responded to a residence located in the 2000 block of Stargrass Ct. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 40-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and pulled her to the ground where he struck her multiple times. When a family member attempted to intervene, the accused retrieved a knife and chased the parties out of the home where they encountered police. Minor injuries were reported. Following the investigation, the accused, identified as Antonio Jose **GUERRA**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On June 17 at 12:26PM, officers responded to the 17100 block of Shell Cast Lp. in Dumfries (22026) to investigate a suspicious person. Officers attempted to detain a woman, later identified as the accused, and when she actively resisted and attempted to flee from officers. The accused struck one officer with her bag before being detained without further incident. No injuries were reported. The accused was found in possession of suspected illegal drugs. Following the investigation, the accused, identified as Micayla Rae **CALPANIA**, was arrested.
