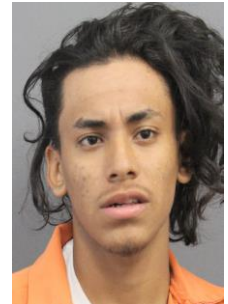

Incidents

Aggravated Assault - On June 18 at 8:01PM, officers responded to the 17900 block of Swans Creek Ln in Dumfries (22026) to investigate an assault. The investigation revealed the victim, a 36-year-old man, and his spouse were placing their young child into their vehicle when several occupants inside a gray Jeep Cherokee passed. As the vehicle drove by the victim, an occupant fired multiple BB projectiles, striking the victim in the arm and the victim's vehicle. The suspect vehicle quickly left the area. During a canvass of the neighborhood, a second victim was located who had also been struck as well as another vehicle. Minor injuries were reported. The occupants were believed to be in their late teens or early 20s. The suspect who fired the BBs was believed to be a black male with short hair wearing gray clothing.

Abduction | Assault & Battery - On June 19 at 12:44AM, officers responded to a residence located in the 13900 block of Mount Pleasant Dr in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 16-year-old female juvenile, was being held against her will by an acquaintance, identified as the accused. Officers located the victim inside the home who was found to have been injured in a previous assault by the accused. Minor injuries were reported. When officers attempted to detain the accused, he resisted. Following the investigation, the accused, identified as Dayro Yafeth **MATUTE-RIVERA**, was arrested.

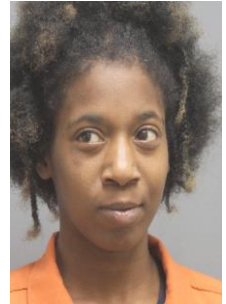

Assault & Battery on a Law Enforcement Officer [LEO] – On June 18 at 12:55PM, officers responded to the Elevations One Apartments located in the 14300 block of Jefferies Rd in Woodbridge (22191) to investigate a trespassing complaint. The investigation revealed multiple individuals had forced entry into a vacant apartment. During the investigation, another party, identified as the accused, approached officers wanting access to the apartment. As officers were speaking to the accused, she fled on foot before being quickly detained. While transporting the accused for processing, she began kicking the partition in a cruiser. The accused became increasingly agitated in custody, and at one point, kicked towards officers. No injuries were reported. Following the investigation, the accused, identified as Sharney Angel **STEWART**, was arrested. Two other individuals were arrested for unlawful entry in connection with the investigation.
