Malicious Wounding | Strangulation [Previously Released] – On June 15 at 2:54AM, officers responded to the 13700 block of Smoketown Rd. in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 31-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck before throwing her to the ground where he struck and kicked her multiple times. At one point during the altercation, the accused went into the victim's purse and took her phone before continuing the assault. When responding officers attempted to make contact with the accused, he ran from the area. The victim was treated on scene for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Octavious HODGES. Attempts to locate the accused have been unsuccessful.



Strong-Arm Robbery *SUSPECT IDENTIFIED – On June 19, officers identified one of the suspects involved in the robbery that was reported to have occurred in the 1430 block of Jeffries Rd. in Woodbridge (22191) on June 16. Attempts to locate the accused, identified as Makubani Sun **REEL**, have been unsuccessful. The investigation continues as officers seek to apprehend the accused and attempt to identify the other men involved in the robbery.

Strong-Arm Robbery [Previously Released] – On June 16 at 5:49PM, officers responded to the 14300 block of Jeffries Rd. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 37-year-old man, was approached by a group of men who held him down while they took his cash app card. No injuries were reported, and no suspect descriptions were provided to the officers.

Incidents

Shooting Investigation – On June 19 at 11:33PM, officers responded to the 10500 block of Croatia Way in Manassas (20109) to investigate a shooting. The investigation revealed a 40-year-old man was reportedly assaulted and sustained a gunshot wound to his lower body before entering a business on Sudley Rd where police were contacted. Officers initially determined the man was involved in an altercation with a possible acquaintance. The area was checked and no additional injuries or property damage were located. The man was treated at an area hospital for non-life threatening injuries. **This incident does not appear random.**
