Updates

Felony Murder Investigation *ARREST - On June 23, detectives charged a juvenile suspect in connection to the death of a 17-year-old juvenile stemming from an incident that occurred at the Misty Ridge Apartments located in the 15000 block of Lost Canyon Ct in Woodbridge (22191) on June 18. Over the course of the investigation, detectives identified the shooter as an 18-year-old man who resided in the apartment complex. The investigation revealed the deceased and at least one other party, identified as the juvenile accused, conspired to rob the 18-year-old male resident of marijuana and money at his apartment. The parties were visiting the area from South Carolina and had prior knowledge of the targeted location. On the evening of the incident, the deceased and accused arrived at the apartment and attempted contact at the front door. After receiving no answer, the deceased attempted to force entry into the apartment by breaking a window into a room where the 18-year-old resident was sleeping. As the deceased entered the apartment, the 18-year-old fired rounds from his handgun, ultimately fatally striking the deceased. The accused fled the area, and at one point, fired back towards the complex. No other injuries were reported. With the assistance of Virginia State Police, the accused was taken into custody in the Fredericksburg area without incident. Two firearms were recovered. Following the investigation, the accused, identified as a **15-year-old male juvenile**, was arrested in connection to the death of his associate during the commission of a felonious crime. This case was aided with the assistance of Virginia State Police, Fredericksburg (VA) police, Gaffney (SC) police, Spartanburg (SC) police, Cherokee County (SC) sheriff, and Cherokee County (SC) juvenile services. The investigation continues.

Homicide Investigation [Previously Released] – On June 18 at 12:44AM, officers responded to the Misty Ridge Apartments located in the 15000 block of Lost Canyon Ct in Woodbridge (22191) to investigate a shooting. Responding officers located a 17-year-old male juvenile in an outdoor stairwell suffering from gunshot wounds. Officers provided aid to the juvenile who was transported to an area hospital where he later died. The investigation revealed the suspect had fled on foot after the shooting. A police K-9 and Fairfax County police helicopter searched the area for the suspect who was not located. An apartment in the complex was also struck during the encounter. No other injuries or property damage were reported. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who has information to assist in the investigation. **Preliminarily, this incident does not appear to be random.** Due to the age of the deceased, their identity will not be disclosed by law enforcement at this time. More information will be released as it becomes available. The investigation continues.

Fatal Crash Investigation – On June 22 at 3:22PM, crash investigators responded to the area of Fitzwater Dr and Manley Rd in Nokesville (20181) to investigate a single vehicle crash. The investigation revealed the driver of a 2013 Infiniti G37 was traveling west on Fitzwater Dr at a high rate of speed when the driver lost control of the vehicle which left the roadway, striking multiple trees and rotating before coming to rest. The driver of the vehicle was not wearing a seatbelt at the time of the collision and was ejected from the vehicle. The driver was transported to an area hospital where he died from injuries sustained in the collision. No other vehicles were involved in the collision. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

Death Investigation – On June 23 at 4:46PM, officers responded to Lake Manassas located at 9030 Burwell Rd. in Nokesville (20181) to investigate a drowning. The investigation revealed a 45-year-old man, and a family member were swimming in the lake when he appeared to struggle before submerging in the water. Fire and rescue located and removed the man from the water where he was pronounced dead. The body was transported to the Medical Examiner's Office for an autopsy and determination of cause of death. At this time, there is no foul play concerning the death. The investigation continues.

Shooting into a Residential Dwelling – On June 22 at 3:57PM, officers responded to a residence located in the 8400 block of Carneros Valley Ct. in Bristow (20136) to investigate a destruction of property. The investigation revealed the occupants of the home heard gunfire and located damage to a side window. No injuries or additional property damage were reported.

Strong-Arm Robbery – On June 23 at 3:04AM, officers responded to the 8300 block of Sudley Rd. in Manassas (20109) to investigate a robbery. The investigation revealed the victims, a 33-year-old woman and a 39-year-old man, were approached by five men. During the encounter, the suspects struck and kicked the male victim and grabbed the female victim's forearm before taking a backpack and leaving the area. The male victim was treated at an area hospital for non-life threatening injuries and the female victim reported minor injuries. A police K-9 searched the area for the suspects who were not located. The suspects were only described as Hispanic males.

Assault & Battery on a Law Enforcement Officer [LEO] – On June 21 at 7:42PM, officers were in the area of Saxophone Way and Bel Air Rd. in Woodbridge (22191) when they observed the accused who had active arrest warrants. When officers attempted to detain the accused, she actively resisted and ran from officers. After a short foot pursuit, officers temporarily detained the accused, who continued to actively resist and refused to follow officer's commands. During the encounter, the accused struck the officer which allowed her to separate and flee the area. The officer reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Alejandra Yvette **GARCIA**. Attempts to locate the accused have been unsuccessful.

Rape Investigation – On June 22, detectives concluded an investigation into a sexual assault that was reported to have occurred in the 1400 block of Lee Hwy. in Gainesville (20155) on June 8. The investigation revealed the victim, a 54-year-old woman, arranged to meet with an acquaintance, identified as the accused, earlier that morning. At one point during the encounter, the accused refused to let the victim leave and sexually assaulted her. The accused then sexually assaulted the victim at additional locations in the Gainesville area before the two stopped at a local business later that morning. While at the business, the victim was able to separate from the accused as employees of the business contacted the police. Following the investigation, detectives obtained arrest warrants for the accused, identified as Tyrone Andrew McKinley **CAMPBELL**, who was taken into custody on June 22 by members of the U.S. Marshal's Fugitive Task Force.

Attempted Malicious Wounding of a Corrections Officer – On June 24 at 12:09AM, officers responded to the Prince William–Manassas Regional Adult Detention Center (ADC) located at 9311 Lee Ave. in Manassas (20110) to investigate an attempted assault on staff members. The investigation revealed ADC staff were attempting to assist an inmate, identified as the accused, when he displayed a sharp object wrapped in a towel. When staff went to detain the accused, he cut one staff member and attempted to stab others before being secured without further incident. The initial staff member reported minor injuries. Following the investigation, the accused, identified as Bryan **HERNANDEZ DIAZ**, was charged.

Strangulation (Domestic Related) – On June 21 at 3:17AM, officers responded to the Reid’s Prospect Apartments located in the 4400 block of Daisy Reid Ave. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 36-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim then his neck before eventually separating. Minor injuries were reported. Following the investigation, the accused, identified as Giovana Loayza **GUTIERREZ**, was arrested.

Strong-Arm Robbery – On June 22 at 7:56AM, officers responded to the 13500 block of Minnieville Rd. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 57-year-old woman, was approached by an unknown man, later identified as the accused, who took her purse and left the area in a vehicle. While investigating the incident, officers were informed the accused was attempting to use the victim’s credit cards at local businesses. Officers responded to the area near the businesses and located the vehicle on Minnieville Rd. where a vehicle stop was initiated. The accused disregarded the officer’s emergency equipment and fled. After a short vehicle pursuit, the vehicle stopped at Noblewood Plaza where the accused attempted to flee on foot before being detained without further incident. The accused was found in possession of the victim’s purse and suspected illegal drugs. No injuries were reported. Following the investigation, the accused identified Ronald Walter **RAMIREZ**, was arrested.
