

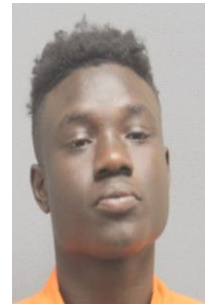


DAILY INCIDENT REPORT

Updates

Residential Burglary *ADDITIONAL ARREST - On June 24, officers concluded the investigation into the burglary that was reported to have occurred at the Dale Forest Apartments located in the 4300 block of Welsh Ln. in Woodbridge (22193) on June 20. While investigating the incident, officers determined the accused was the only other member of the group involved in the burglary. On June 24, officers identified and located the accused, Ibrahim **BARRIE Jr.**, in the Woodbridge area and arrested him without incident. Officers previously arrested one other individual in connection to the incident.

Residential Burglary [Previously Released] - On June 21 at 11:18AM, officers responded to investigate a burglary that was reported to have occurred at the Dale Forest Apartments located in the 4300 block of Welsh Ln. in Woodbridge (22193) on the morning of June 20. The investigation revealed the accused was with a group of other individuals in the apartment complex when an apartment was forcibly entered. The group eventually left the area with an electric bike that was taken from the balcony. Later that day, the accused pawned the bicycle at a local business. While investigating the incident, officers observed the accused in the apartment complex where they were detained without incident. Following the investigation, the accused, identified as Diego Alberto **MUNOZ-VILLEDA**, was arrested. The investigation continues as officers attempt to identify the other individuals involved in the incident.

Incidents

Strangulation (Domestic Related) – On June 24 at 8:43PM, officers responded to The Crossings at Summerland Apartments located in the 13700 block of Keelingwood Cl. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 25-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck later that day before the parties separated. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Demarcus Rashard **WALLEY**. Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery – On June 25 at 3:25PM, officers responded to the 14400 block of Richmond Hwy. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 57-year-old woman, was walking to her vehicle when she was approached by an unknown man. During the encounter, the man pushed the victim, before grabbing her purse and running away. No injuries were reported.

Last seen wearing a white tank top, black pants, black/white slippers and carrying a black jacket

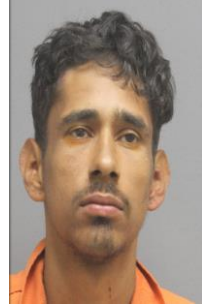

Arrests

Armed Robbery – On June 25 at 12:42PM, officers responded to Walmart located at 8386 Sudley Rd. in Manassas (20109) to investigate a robbery. The investigation revealed store security confronted a man, later identified as the accused, concealing merchandise. During the encounter, the accused brandished a knife towards the employee before walking out of the store with the unpaid items. Later that day, officers observed the accused in the area. When officers attempted to detain the accused, he actively resisted. After a brief struggle, the accused was detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Francisco Talavera **PERALTA**, was arrested.
