Incidents

Fatal Crash Investigation – On June 16 at 11:02AM, officers responded to the intersection of Old Bridge Rd. and Harbor Dr. in Woodbridge (22193) to investigate a crash. The investigation revealed the driver of a 2001 Ford F150 pickup truck was traveling westbound on Old Bridge Rd. approaching the intersection with Harbor Dr. when a 2020 Ford Edge traveling eastbound on Old Bridge Rd. entered the intersection in front of the truck's path of travel. The truck and Edge collided within the intersection. Both drivers and a passenger in the vehicles were transported to area hospitals. On June 27, crash investigators were notified that the male passenger who was injured in the Edge died as a result of injuries sustained during the crash. All other involved parties are expected to survive. Investigators determined that speed, alcohol, and drugs were not factors for the driver. At the time of the collision, the driver of the Edge, identified as Doris Ann **GROSSKOPF**, was charged. The investigation continues.

Strong-Arm Robbery – On June 25 at 2:39PM, officers responded to investigate an assault that was reported to have occurred in the 4000 block of the Prince William Pkwy. in Woodbridge (22193) earlier that day. The investigation revealed the victim, an 18-year-old man, arranged to sell a pair of shoes to an unknown man in the above area. Before the sale was completed, the man grabbed the shoes from the victim and began to drive out of the parking lot. The victim held onto the shoes and was dragged for a short distance before he fell to the ground as the suspect continued to drive out of the area. The victim was treated at an area hospital for non-life threatening injuries where police were contacted. A pair of Jordan-style shoes were reported missing. The suspect was described as a white male with long hair driving a white sedan.

Assault with a Caustic Substance (Domestic Related) – On June 26 at 9:07PM, officers responded to the Elevations One Apartments located in the 14300 block of Bellona Rd. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation in the parking lot that escalated. During the encounter, the accused sprayed the victim in his face and upper body with an unknown substance before driving away in her vehicle. The victim was treated at the scene for minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Tahjaia **CORUM-HILL**. Attempts to locate the accused have been unsuccessful.
