### Incidents

**Armed Robbery** – On August 11 at 4:49AM, officers responded to the 7-Eleven located at 18750 Fuller Heights Rd. in Triangle (22172) to investigate a robbery. The investigation revealed an unknown man entered the store and eventually walked behind the service counter where he brandished a knife towards the employee before demanding money. When the employee did not comply, the suspect took tobacco products and ran out of the store. Officers and a police K-9 searched the area for the suspect who was not located. No injuries were reported.

**Attempted Malicious Wounding of a Law Enforcement Officer [LEO]** – On August 11 at 2:06PM, officers responded to the Walmart located at 9401 Liberia Ave. in Manassas (20110) to investigate a fraudulent return. The investigation revealed a woman, identified as the accused, made a fraudulent return before leaving the store where a man, who also made a fraudulent return was located by officers. When officers attempted to make contact with the man, he ran out of the store and got into a vehicle being driven by the accused. When an officer attempted to stop the vehicle, the accused continued driving and grazed the officer with the vehicle as she drove out of the parking lot. The officer reported minor injuries. While investigating the incident, officers identified the accused as Brenda **CASTILLO-SAMO**, and obtained warrants for her arrest. Attempts to locate the suspect have been unsuccessful.

**Commercial Burglaries** – On August 10 at 8:20AM, officers responded to investigate multiple burglaries that were reported to have occurred at three separate businesses in the 13300 block of Minnieville Rd. earlier that morning around 3:25AM. The investigation revealed an individual forced entry through the front glass doors of Kababayan Filipino Kitchen, Afghan Grill Kabob, and Tazo Pizza, which were all found damaged. An undisclosed amount of money was missing from two of the businesses. The suspect was described as a male last seen wearing a white mask, a black jacket, light-colored sweatpants, and white gloves.

**Commercial Burglary** – On August 9 at 10:02AM, officers responded to Pho Saigon located at 2890 Dale Blvd. in Woodbridge (22193) to investigate a burglary. Video surveillance revealed at approximately 2:15AM, an unknown individual forced entry into the business through the glass front door which was found damaged. An undisclosed amount of money was reported missing.

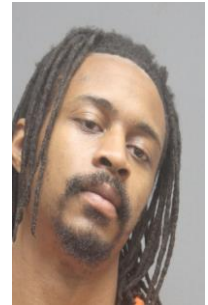

## Arrests

**Shooting at an Occupied Vehicle** -- On August 11 at 11:10PM, officers responded to the 1300 block of E. Longview Dr. in Woodbridge (22191) to investigate a burglary. The investigation revealed the victim, a 28-year-old woman, woke to an acquaintance, identified as the accused, forcing entry into her home and destroying her property. The victim was eventually able to leave the residence and the accused left shortly after in his vehicle. A short time later, the accused's vehicle was observed firing a round which struck a separate occupied vehicle in the 1300 block of Saxon St. Officers quickly located the accused's vehicle and detained the accused, who was the sole occupant of the vehicle. Officers located a firearm inside the vehicle and determined the accused punctured the tires of the victim's vehicle before entering her home. No injuries were reported, and no property was reported missing. Following the investigation, the accused, identified as Adam **WELLS**, was arrested.

**Malicious Wounding of a Law Enforcement Officer [LEO]** – On August 10 at 12:45AM, officers conducted a vehicle stop in the area of Smoketown Rd. near Beaver Ford Rd., in Woodbridge (22192) where they determined the driver was intoxicated. Officers took the driver, identified as the accused, into custody and transported him to the Adult Detention Center. While processing the accused, he began to resist and struck an officer in the upper body on more than one occasion. The accused was re-secured without further incident. No injuries were reported. Following the investigation, the accused, identified as Dean **CAMPBELL**, was arrested.

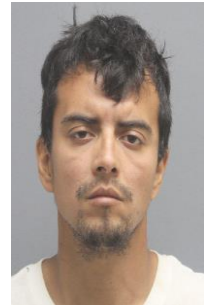

**Malicious Wounding (Domestic Related)** – On August 9 at 9:07AM, officers responded to a residence located in the 7800 block of Meadow Ct. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 46-year-old man and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim multiple times before striking an 18-year-old male family member who attempted to intervene. The accused then threw an object striking the 18-year-old family member in the face. The parties eventually separated, and the 18-year-old victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Edwin Alberto **MENDOZA**, was arrested.

**Malicious Wounding (Domestic Related)** -- On August 9 at 11:37PM, officers responded to a residence located in the 6900 block of Bitterroot Ct. in Gainesville (20155) to investigate a domestic dispute with weapons. The investigation revealed the victim, a 41-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and then struck a 43-year-old male family member who attempted to intervene. The accused then retrieved a baseball bat and struck the male family member with the bat before leaving the residence. The accused retrieved a shovel and struck the mailbox before he left the area. Responding officers located the accused nearby where, after a brief struggle, he was detained without further incident. Minor injuries were reported. Following the investigation, the accused, identified as a **13-year-old male juvenile**, was arrested.

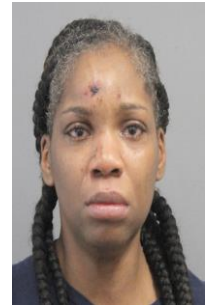

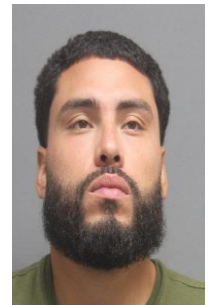
**Felony Child Neglect** – On August 10 at 9:43PM, officers responded to the Potomac Vista Apartments located in the 14100 block of Bay Vista Dr. in Woodbridge (22191) to investigate the report of a domestic dispute. Upon arrival, officers encountered a woman, later identified as the accused, and determined she was involved in a verbal dispute. During the investigation, officers located an unattended infant child inside an apartment and determined the accused left the child unattended for an extended period of time. Officers also determined the accused was intoxicated and detained her without incident. The baby did not appear harmed and was turned over to known parties. Following the investigation, the accused, identified as Sarah Elizabeth **HUFF**, was arrested.

Further investigation revealed the child was handling an object with suspected illegal drug residue on it which was utilized earlier in the day by the accused. The child is expected to recover. Following the investigation, the accused, identified as Yosely **ARGUETA**, was arrested.
