Incidents

Shooting Investigation – On August 18 at 7:27PM, officers responded to the 12700 block of Dulcinea Pl. in Woodbridge (22192) to investigate a shooting. The investigation revealed two groups exchanged gunfire before the parties dispersed in two separate vehicles described as a gold minivan and a silver sedan. While checking the area, officers located three unoccupied vehicles that were struck by gunfire and shell casings on the ground. No involved parties were initially located. While investigating the incident, officers were informed of a 19-year-old man being treated at an area hospital for non-life threatening gunshot wounds. The man refused to cooperate further with detectives regarding the incident. No additional injuries or property damage were reported.

Malicious Wounding (Domestic Related) – On August 19 at 12:53AM, officers responded to a residence located in the 1400 block of Maryland Ave. in Woodbridge (22191) to investigate a stabbing. The investigation revealed the victims, a 31-year-old woman and a 44-year-old man, were inside the residence when an acquaintance, identified as the accused, entered the home without permission. During the encounter, the accused threatened the male victim and brandished a machete-style knife. The accused struck the male victim with the knife multiple times, including in the face, before physically striking the female. The parties separated and the police were contacted. The male victim was treated at an area hospital for non-life threatening injuries while the female victim reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Valentino **CRUZ REYES**. Attempts to locate the accused have been unsuccessful.

Aggravated Assault – On August 17 at 3:03PM, officers responded to investigate an assault that was reported to have occurred in the area of Daniel Stuart Sq. and Opitz Blvd. in Woodbridge (22191) earlier that morning at approximately 2:30AM. The investigation revealed the victim, a 65-year-old man, and an unknown man were involved in a verbal altercation that escalated. During the encounter, the man got out of a vehicle while brandishing a machete-style knife and struck the victim in the arm with the knife before leaving the area. The victim went to an area hospital later where police were contacted. The suspect was only described as a male with short hair driving a light blue Chevy sports car.

Strong-Arm Robbery – On August 16 at 10:17PM, officers responded to the area of Stonehouse Lp. near Coppermine Dr. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 27-year-old man, was walking in a wooded area near the above location when he was approached from behind by an unknown woman who attempted to take his wallet. During a brief struggle, the victim was scratched by the woman and was able to maintain control of the wallet as the suspect walked away. The victim left the area and contacted the police. Minor injuries were reported.

Suspect Description:

A black female, approximately 5'6", with a skinny build, and short hair

Last seen wearing a red shirt and black fitted pants

Commercial Burglary – On August 17 at 12:30PM, officers responded to The Woods at Victoria Park located in the 16800 block of Flotilla Way in Woodbridge (22191) to investigate a burglary. The investigation revealed sometime between 5:30PM on August 16 and 12:00PM on August 17, forced entry was made into a maintenance room through a window. No property was reported missing.

Residential Burglary – On August 17 at 6:27PM, officers responded to a residence located in the 14600 block of Minnieville Rd. in Woodbridge (22193) to investigate a burglary. The investigation revealed sometime between August 7 and August 16, forced entry was made into the home through a window that was found damaged. Professional dolls were reported missing and spray paint was used in several areas of the home.

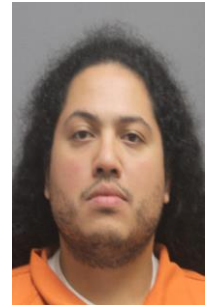

Arrests

Malicious Wounding (Domestic Related) – On August 19 at 2:02AM, officers responded to the Woodbridge Station Apartments located in the 1300 block of Eisenhower Cl. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused brandished a firearm before physically striking the victim in the head and then grabbing her neck. The accused continued to assault the victim before officers arrived and detained the accused inside the apartment. Further investigation revealed the accused had left the firearm unsecured and accessible to a 3-year-old child who was also inside the apartment. The victim was treated at the scene for minor injuries. No additional injuries were reported. Following the investigation, the accused, identified as Luis **CRUZ-VARGAS**, was arrested.



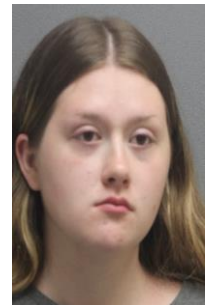

Malicious Wounding – On August 19 at 12:13AM, officers responded to a residence located in the 3900 block of Hidden Valley Ct. in Dumfries (22025) to investigate a stabbing. The investigation revealed the victim, a 20-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed a pair of scissors and stabbed the victim in the back before the parties separated. The victim was treated at an area hospital for minor injuries. Following the investigation, the accused, identified as Alivia Marie **MCCLARREN**, was arrested.

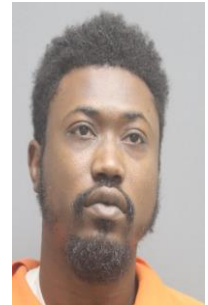

Reckless Handling of a Firearm – On August 17 at 9:15PM, officers responded to a residence located in the 8200 block of Wycliffe Ct. in Manassas (20109) to investigate a reckless handling. The investigation revealed the accused was handling a firearm when a round discharged and struck a 27-year-old female family member. The accused quickly rendered aid. The victim was treated at an area hospital for a non-life threatening gunshot wound where police were contacted. No additional injuries or property damage were reported. Following the investigation, the accused, identified as Travis Lamont **SINGLETARY**, was arrested.



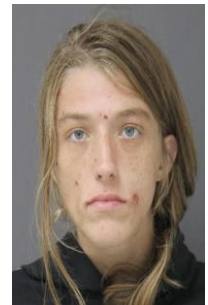

Contributing to the Delinquency of a Minor – On August 15 at 8:42PM, officers responded to Veterans Park located at 14300 Veterans Dr. in Woodbridge (22191) to investigate a child neglect. The investigation revealed earlier that evening, a woman, later identified as the accused, asked an unknown man at the skate park to watch her 7- and 8-year-old boys. The man contacted the police when the accused did not return to the park after some time. While investigating the incident, the accused returned to the park where she was detained without incident. The children did not appear injured and were turned over to known parties. Following the investigation, the accused, identified as Autumn Maree **FOSS HALE**, was arrested.
