RE: REALLOCATE, TRANSFER, BUDGET, AND APPROPRIATE \$3,600,000 IN AMERICAN

RESCUE PLAN ACT FUNDING FROM THE COVID-19 SPECIAL REVENUE FUND TO THE EMERGENCY OPERATIONS CENTER RENOVATION CAPITAL PROJECT FUND

ACTION: APPROVED

**WHEREAS**, the American Rescue Plan Act (ARPA) of 2021 was passed by Congress on March 10, 2021, and signed into law on March 11, 2021. Prince William County received \$91,357,060 from ARPA's Coronavirus State and Local Fiscal Recovery Fund (CSLFRF) to support response to and recovery from the COVID-19 public health emergency; and

**WHEREAS,** Prince William Board of County Supervisors (Board) Resolution Number (Res. No.) 22-317 authorized \$5,000,000 towards the renovation of the County's Emergency Operations Center (EOC) and \$3,000,000 to support the County's response to COVID-19 (testing and vaccinations, personal protective equipment, and other emergency protective measures). Board Res. No. 21-352 authorized \$5,000,000 to support the County's response to COVID-19; and

**WHEREAS,** the EOC renovation project is ongoing, and the County's emergency response actions to the COVID-19 pandemic have concluded; and

**WHEREAS,** as a result of additional roof and mechanical issues discovered in the Owens building during the design phase, an additional \$2,200,000 is required to fully implement phases 3 and 4 of the EOC renovation capital project; and

**WHEREAS**, capital reporting requirements of the (CSLFRF) require that \$1,400,000 of audiovisual system equipment, design, licenses, and furnishings for the EOC be transferred to the existing capital project; and

**WHEREAS,** \$3,000,000 of ARPA funding is available in the COVID-19 Special Revenue Fund previously allocated for emergency response; and

**WHEREAS**, \$600,000 of ARPA funding is available in the COVID-19 Special Revenue Fund previously allocated for premium pay;

**NOW, THEREFORE, BE IT RESOLVED** that the Prince William Board of County Supervisors hereby reallocates, transfers, budgets, and appropriates \$3,600,000 in American Rescue Plan Act funding from the COVID-19 Special Revenue Fund to the Emergency Operations Center Renovation Capital Project Fund to complete the Emergency Operations Center renovation project and critical mechanical upgrades in the Owens Building, as designed.
