Updates

Murder Investigation *ARREST | SUSPECT WANTED - During the ongoing investigation into the murder of a 23-year-old woman killed in a shooting that occurred in the area of Bronson Ct. and Brickwood Dr. in Woodbridge (22193) on February 2, detectives have arrested one man and obtained an arrest warrant for another man involved in the encounter. The victim was found fatally shot while inside her vehicle when officers arrived on the scene around 2:07AM. The investigation revealed a murder-for-hire was arranged to kill the victim. Detectives further learned the suspect currently in custody, identified as Drew Courtney BUCHANAN, carried out the act in murdering the victim. On October 15, BUCHANAN, was located in the Manassas area and arrested without incident. An additional suspect, identified as Denzel Scott WADE, was determined to have been present with BUCHANAN at the time of shooting and is currently being sought by police on an active arrest warrant. Additional charges against other involved parties are pending in this investigation. Anyone with information on the whereabouts of the wanted suspect or who can otherwise aid in the investigation is asked to contact the police. More information will be released when available. The investigation continues.

Homicide Investigation *VICTIM IDENTIFIED [Previously Released] – Following the notification of a next-of-kin, police are announcing the identity of the victim killed in the shooting that occurred in the area of Bronson Ct. and Brickwood Dr. in Woodbridge (22193) around 2:00AM on February 2. The victim, identified as Egypt Zapporah CARTER, of Burlington, NC, was fatally shot on Brickwood Dr. while inside her vehicle. Detectives are continuing to actively investigate the incident to determine what led up to the shooting and are seeking to speak with anyone who has information regarding this incident.

Homicide Investigation [Previously Released] – On February 2 at 2:07AM, officers responded to the area of Bronson Ct. and Brickwood Dr. in Woodbridge (22193) to investigate a shooting. Upon arriving in the area, officers located a 23-year-old woman inside of a vehicle suffering from gunshot wounds. Fire and rescue responded and pronounced the victim dead on the scene. The preliminary investigation revealed the woman was sitting in her vehicle when she was fatally struck by gunfire. Officers located a small mixed-breed dog inside the vehicle that was unharmed and turned over to Animal Control Officers. No additional injuries or property damage were reported. Further information regarding the identity of the deceased will be released pending notification of a next-of-kin. Detectives are actively investigating the incident to determine what led up to the shooting. More information will be released when available. Strangulation (Domestic Related) [Previously Released] - On October 23 at 9:57PM, officers responded to the Stone Pointe Apartments located in the 14900 block of Potomac Heights Pl. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 23-year-old-woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck and struck her face before leaving the area. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Remy Devontae **FARRELL-JURY.** Attempts to locate the accused have been unsuccessful.

Incidents

Death Investigation – On October 28 at 10:40AM, crash investigators responded to the parking lot of Cabela's located at 5291 Wellington Branch Dr in Gainesville (20155) to investigate a crash involving a fatality. The investigation revealed the driver of a 2024 Chevrolet Silverado, identified as a 67-year-old man, was in the parking lot of the business and is believed to have suffered a medical emergency. At one point, the driver let off the brake and slowly proceeded across the parking lot before impacting a boat trailer. A short time later, an employee of business observed the unconscious driver behind the wheel of the vehicle and contacted emergency services. Responding officers provided immediate first aid to the driver who was transported to an area hospital and pronounced deceased. No other occupants were in the vehicle. Due to indications the death resulted from a medical emergency and not injuries sustained from the collision, the incident will not be considered a fatal crash.

Brandishing of a Weapon – On October 28 at 12:53AM, officers responded to El Gicarito 2 located at 10611 Lomond Dr. in Manassas (20109) to investigate a brandishing. The investigation revealed the victim, a 34-year-old man, was sitting inside his vehicle in the parking lot when he was approached by an unknown man. During the encounter, the man brandished a machete-style knife. When the victim contacted the police, the suspect left the area in a grey Nissan Xterra. No injuries or property damage were reported. The suspect was described as a Hispanic male between 40-50 years of age.

Murder Investigation - On October 28 at 2:39AM, officers responded to a residence located in the 2500 block of Paxton St in Woodbridge (22192) to investigate a shooting. A family friend contacted police after he received information that a shooting had occurred at the home. When officers arrived at the residence and located one of the parties, later identified as the accused, who was detained without incident. The investigation revealed the accused reportedly shot and killed his father, identified as a 56-year-old man, and the family dog, an approximately 1-year-old Labrador Retriever, during an altercation. The

accused and victim reside together at the home. There were no other occupants inside the residence at the time of the incident. Both the victim and dog were pronounced dead on scene. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who has information to aid in the investigation. Following the investigation, the accused, identified as Christopher Tyler **ROSE**, was arrested. More information will be released as necessary. The investigation continues.

The investigation revealed the victim, a 16-year-old female juvenile, and another known student, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused sprayed the victim with an eye irritant before the parties separated. Minor injuries were reported.
