Armed Robbery *SUSPECT IDENTIFIED | ARREST – On October 26, detectives identified and arrested a **16-year-old male juvenile** in connection to the armed robbery that was reported to have occurred at the 7-Eleven located at 16170 Country Club Dr. in Dumfries (22025) on March 5.

Armed Robbery [Previously Released] – On March 5 at 5:16AM, officers responded to investigate a robbery that was reported to have occurred at the 7-Eleven located at 16170 Country Club Dr. in Dumfries (22025) at approximately 4:28AM. The investigation revealed an unknown man brandished a firearm towards the employee and demanded money and tobacco products. The suspect fled the store with an undisclosed amount of money and tobacco products. No shots were fired, and no injuries reported. The suspect was described as wearing a black ski-style mask and a black jacket.

Incidents

Armed Robberies – On November 1 at 2:30PM, officers responded to Todos Supermarket located at 13905 Richmond Hwy. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victims, a 29-year-old woman and a 49-year-old man, were approached by an unknown man in the parking lot. During the encounter, the suspect opened the driver's door before brandishing a firearm and demanding property. The suspect took the male victim's wallet and phone before leaving in a light-colored F-150 truck. While investigating the incident, a second armed robbery was reported in the 14400 block of Gemstone Dr. where the suspect of similar description brandished a firearm towards a 61-year-old woman and a 29-year-old woman. The suspect took an undisclosed amount of money before leaving in a vehicle matching the previous robbery. As officers were checking the area, the suspect vehicle was located unoccupied in the commuter lot off Prince William Pkwy near I-95. Officers also located some of the stolen property and determined the truck was previously reported stolen. No injuries were reported. The investigation continues as officers attempt to identify the suspect(s) involved in the investigation.

Suspect Description:

A Hispanic male, 40's, approximately 5'5", with a thin build and a mustache

Brandishing of a Firearm – On October 31 at 8:16PM, officers responded to the 1200 block of Easy St. in Woodbridge (22191) to investigate a brandishing. The investigation revealed the victim, a 22-year-old man, heard a loud noise outside and observed a vehicle had struck his vehicle. As the victim walked towards the vehicles, an occupant of the other vehicle brandished a firearm towards the victim before leaving the area. No shots were fired, and no injuries were reported.

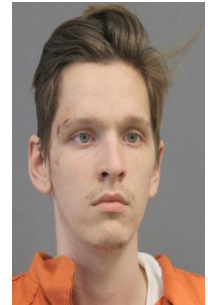

Arrests

Involuntary Manslaughter – On November 2 at 10:42PM, officers responded to the commuter lot located at 2250 Prince William Parkway in Woodbridge (22192) to investigate a shooting. Officers arrived on the scene and located the victim, later identified as a 27-year-old man, in the parking lot suffering from a gunshot wound to the upper body. Officers provided aid to the victim who was transported to an area hospital where he later died. The investigation revealed the accused and victim were involved in an altercation that escalated. During the encounter, a struggle ensued over a firearm, and the victim was shot. A police K-9 and Fairfax County police helicopter searched the area for the suspect who left the scene and was not initially located. With the assistance of Fairfax County police, detectives located the accused later in the day at his residence in Vienna where he was detained without incident. **This incident was not random.** Following the investigation, the accused, identified as Christian Miller **GEIGER**, was arrested.

Strangulation (Domestic) – On November 1 at 10:22PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 8400 block of Craggan Ln. in Manassas (20109) on September 21. The investigation revealed the victim, a 19-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and wrapped his arm around her neck before the parties separated. The victim recently reported the incident and minor injuries sustained at the time of the incident. Following the investigation, officers obtained arrest warrants for the accused, identified as Sharafi **MOHAMMADAMIN**, who was arrested in Fairfax County on November 3.

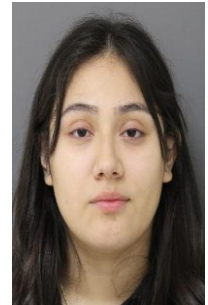

Abduction (Domestic) – On November 1 at 5:28PM, officers responded to a residence located in the 5200 block of Medwick Ct. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 39-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused scratched the victim before he prevented her from leaving the room. Eventually, the parties separated, before a second assault occurred where the accused scratched a 10-year-old family member. Minor injuries were reported. Following the investigation, the accused, identified as Graciela Estafani **VENTURA**, was arrested.

When officers attempted to detain the driver, identified as the accused, he actively resisted. During the encounter, the accused head-butted and kicked officers before being secured without further incident. Minor injuries were reported by the officers. Following the investigation, the accused, identified as Johari **PRAKHAR**, was arrested.

Contributing to the Delinquency of a Minor – On November 1 at 11:29AM, officers responded to The Woods at Victoria Park apartments located in the 2700 block of Cobin Ct. in Woodbridge (22191) to investigate a found child. The investigation revealed the victim, a 10-year-old girl, was located inside a vacant apartment by maintenance personnel. The child had reportedly attended a party at the location the night prior with her 15-year-old brother who had left the location prior to the victim being located. No other occupants were found inside the apartment. While investigating the incident, officers made contact with the children’s mother, later identified as the accused, who eventually met with police. The victim was not injured and released to the custody of known parties. Following the investigation, the accused, identified as Erica Antenette **LAND**, was charged.
