Fatal Crash Investigation *DRIVER CHARGED - On November 6, crash investigators obtained a court summons for a traffic violation citing the driver of the 2021 Mercedes Benz Sprinter van in the fatal collision that occurred in the 10100 block of Lake Jackson Dr. in Manassas (20111) on November 4. The investigation revealed the driver of the van, identified as the accused, was distracted which contributed to the collision that killed a 90-year-old man who was walking on the shoulder of the roadway. Following the investigation, investigators obtained a summons for the accused, identified as Russell Anthony **CAROLLA**, who was served on November 6.

Fatal Crash Investigation [Previously Released] - On November 4 at 4:18PM, officers responded to the 10100 block of Lake Jackson Dr. in Manassas (20111) to investigate a crash involving a pedestrian. The investigation revealed the driver of a 2021 Mercedes Benz Sprinter van was traveling eastbound on Lake Jackson Dr. when the vehicle struck a pedestrian who was walking on the shoulder portion of the roadway. At the location of the crash, no sidewalk is present. The pedestrian was transported to an area hospital where he died later that evening from injuries sustained during the crash. The driver of the striking vehicle remained at the scene and was not injured. Investigators determined that speed was not a factor in the crash. **Crash investigators are asking anyone who may have witnessed this crash to contact police.** Charges are pending as the investigation continues.

Brandishing of a Firearm | Road Rage Related *SUSPECT IDENTIFIED | ARREST - On October 22, officers concluded the investigation into the brandishing that was reported to have occurred at the intersection of Richmond Hwy and Dumfries Rd. in Dumfries (22192) on April 26. While investigating the incident, officers identified the suspect and obtained an arrest warrant. On October 22, the suspect, identified as Alex **COLEMAN**, was located and arrested by Arlington County police.

Brandishing of a Firearm | Road Rage Related [Previously Released] - On April 26 at 4:54PM, officers responded to the intersection of Richmond Hwy and Dumfries Rd. in Dumfries (22192) to investigate a brandishing. The investigation revealed the victim, a 34-year-old man, was driving on Dumfries Rd. when he was involved in a road rage incident with the driver of another vehicle. While both vehicles were stopped at the above intersection and the driver's continued the verbal altercation, the driver of the other vehicle got out of their vehicle and brandished a firearm. The victim remained in his vehicle during the encounter. Eventually, the parties separated without further incident. No shots were fired, and no injuries were reported. The suspect was described as a Hispanic male approximately 25 years old driving a white BMW.

Death Investigation – On November 5 at 4:16PM, officers responded to a residence located in the 4900 block of Asdee Ln. in Woodbridge (22192) to investigate a death. The investigation revealed the victim, a 30-year-old man, was working on a vehicle in the driveway when the vehicle shifted and began to roll, pinning him underneath. The man was pronounced dead on scene. No foul play is suspected with the death. More information will be released as necessary.

Reckless Handling of a Firearm – On November 6 at 9:56PM, officers responded to 4200 block of Lawnvale Dr. in Gainesville (20155) to investigate a shots fired call. The investigation revealed gunshots were heard before a dark-colored vehicle was seen leaving the area. No injuries or property damage were reported. Officers located multiple shell casings on the roadway.

Commercial Burglaries – On November 7 at 4:43AM, officers responded to Glendale Plaza located in the 4100 block of Dale Blvd. in Woodbridge (22193) to investigate multiple burglaries. The investigation revealed sometime between 12:15AM and 4:30AM, forced entry was made into three separate businesses, Pizza Boli's, De Las Sisters Bakery, and Tacos Don Juan, through the front glass door. An undisclosed amount of money and tip jars were reported missing from the businesses.

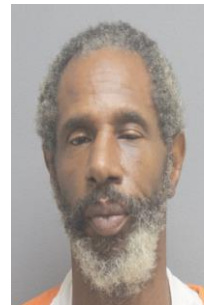

While arresting the man, identified as the accused, he actively resisted and pushed an officer before fleeing on foot. After a short foot pursuit, the accused was detained without further incident. Possession of a Knife on School Grounds – On October 31 at 2:46PM, the School Resource Officer (SRO) assigned to Beville Middle School located at 4901 Dale Blvd. in Woodbridge (22193) was alerted to a student in possession of a knife. The investigation revealed a student, identified as the accused, displayed a knife towards other students while in a classroom. The other students reported the incident to school personnel who notified the SRO. School personnel and the SRO located the accused and took possession of the knife without incident. The SRO determined the knife was not a part of any active threat to other students or staff. Following the investigation, officers sought petitions against the accused, identified as a **13-year-old female student**. After consultation with Juvenile Court Services, the case resulted in formal action and will be handled through the court process at a later date.
