Incidents

Fatal Hit & Run Crash Investigation – On November 3 at 1:22AM, officers responded to the intersection of Prince William Pkwy and Lynn St. in Woodbridge (22191) to investigate an unconscious man in the roadway. The investigation revealed the victim, a 51-year-old man, was believed to have been walking in the roadway of Prince William Pkwy when he was struck by an unknown vehicle which continued driving. A passing motorist observed the pedestrian in the roadway contacted emergency services while rendering aid. The pedestrian was transported to an area hospital where he later died from his injuries. An autopsy confirmed the injuries sustained by the pedestrian were likely the result of being struck by a vehicle. No further information on the driver or striking vehicle is available at this time. **Investigators with the Crash Investigation Unit are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

The deceased pedestrian was identified as Salvador Ernesto **TORRES**, 51, of Woodbridge

Malicious Wounding – On November 7 at 2:34AM, officers responded to a residence located in the 13200 block of Haddock Rd. in Woodbridge (22193) to investigate an assault. The investigation revealed the victim, a 57-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim before striking her in the face with a stone object. The parties separated and the accused left the residence. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Asha Yussef **MOHAMED.** Attempts to locate the accused have been unsuccessful.

Arrests

Sexual Assault Investigation – On November 6, 2024, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence in the Manassas (20110) area of Prince William County in February 2018. The investigation revealed the victim, who was under the age of 12 at the time of the incidents, was inappropriately touched by a man known to her, identified as the accused. The victim recently reported the incidents to police. Following the investigation, detectives obtained arrest warrants for the accused, identified as Willian Alexander **CRUZ ESCOBAR**, who turned himself in to police on November 6, 2024.

Assault & Battery on a Law Enforcement Officer [LEO] – On November 7 at 4:47PM, officers responded to the Potomac Ridge Apartments located in the 2800 block of Woodmark Dr. in Woodbridge (22191) to assist a person in crisis. When officers entered the apartment they observed a woman, later identified as the accused, who was intoxicated and attempting to harm herself. When officers attempted to intervene, the accused kicked and struck an officer before being detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Desiree Debora MAHMOUD, was arrested.
