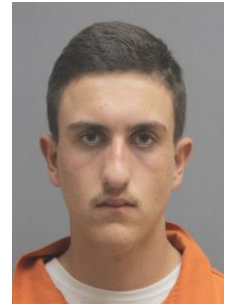
Burglary while Armed *ARREST – On October 29, one of the suspects, identified as Stivan Zlatiev **DIMITROV**, sought in connection to the home invasion that was reported to have occurred at the Ravens Crest Apartments located in the 8100 block of Doubletree Ct in Manassas (20109) on October 13, was arrested. The investigation continues as detectives attempt to locate the second suspect involved in the incident.

Burglary while Armed [Previously Released] – On October 13 at 11:41PM, officers responded to the Ravens Crest Apartments located in the 8100 block of Doubletree Ct in Manassas (20109) to investigate a home invasion. The investigation revealed the victim, a 29-year-old woman, was inside the residence when she heard a knock at the door. When the victim opened the door slightly, two unknown men sprayed her in the face with an eye irritant before forcing their way inside the apartment. Once inside the residence, the men rummaged through and damaged property before leaving. No property was reported missing, and no injuries were reported. **This incident does not appear to be random.**

Strangulation | Abduction (Domestic) – On November 9 at 8:22PM, officers responded to a residence located in the 2600 block of Cristina Ct in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 20-year-old woman, and an acquaintance, identified as the accused, were involved in a physical altercation the day prior. During the encounter, the accused put his hands around the victim’s neck and forcibly prevented her from leaving the residence. The accused then struck the victim in the face when she attempted to defend herself. The parties eventually separated before a verbal argument escalated the following day. When the victim attempted to call police, the accuse grabbed her phone and left the home. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Mohammed Hussein **AL TAMIMI**. Attempts to locate the accused were unsuccessful.

Wanted for 1 count of **strangulation**, 1 count of **abduction**, 1 count of **robbery**, 2 counts of **domestic assault & battery**, and 1 count of **preventing the summoning of law enforcement**

Malicious Wounding (Domestic) – On November 8 at 11:05PM, officers responded to a residence located in the 1500 block of Florida Ave in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 52-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the altercation turned physical, and the victim sustained lacerations to his face. The parties separated and the accused left the area prior to police arriving on the scene. The victim was transported to an area hospital for treatment of non-life threatening injuries. Following the investigation, officers obtained an arrest warrant for the accused, identified as Yovani Anthony **MARTINEZ**. Attempts to locate the accused were unsuccessful.

Brandishing of a Firearm – On November 8 at 2:58PM, officers responded to the area of Richmond Hwy and the Prince William Pkwy in Woodbridge (22191) to investigate a brandishing. The investigation revealed the victim, a 34-year-old man, was involved in a road rage incident with the driver of a black Dodge Ram while both vehicles were traveling in the above area. During the encounter, the other driver reportedly brandished a firearm before the vehicles separated. No shots were fired, and no injuries were reported. Officers are following up on the incident into the identity of the other driver involved.

Residential Burglary – On November 9 at 8:26PM, officers responded to a residence located in the 8200 block of Mineral Springs Dr in Manassas (20112) to investigate a burglary. The homeowner reported to police sometime between 3:00PM and 8:00PM, forced entry had been made into the home through a rear sliding glass door which was found shattered. An undisclosed amount of money was reported missing.

Residential Burglary – On November 8 at 11:04AM, officers responded to a residence located in the 10900 block of Hiram Ct in Manassas (20109) to investigate a burglary. The investigation revealed the homeowner was sitting inside her residence when an unknown man entered through a rear door as asked for drugs. The man then left before returning a second time where he took the homeowner's wallet and purse and left. No physical contact occurred, and no injuries were reported. The suspect was described as a black male with a thin build and beard wearing a white and gray hooded athletic-style jacket.

Attempted Residential Burglary – On November 9 at 1:02PM, officers responded to a residence located in the 1500 block of Dorthy Ln in Woodbridge (22192) to investigate an attempted burglary. The homeowner reported to police an unknown man was observed on home surveillance attempting to enter the home through a rear door. The suspect left the area when the homeowner spoke to him via the home camera. No entry was made into the residence and no property was reported missing. The suspect left towards the area of Blackburn Rd and Colchester Rd. The suspect was last seen wearing a checkered jacket, gray hooded sweatshirt, tan beanie, blue jeans, brown cowboy boots, and green work-style gloves

Arrests

Abduction with Intent to Defile – On November 10 at 12:24PM, officers responded to the area of Blackburn Rd and Delaware Dr in Woodbridge (22191) to investigate an abduction and assault. The investigation revealed the victim, a 21-year-old woman, was followed by an unknown individual, later identified as a juvenile, while walking along Blackburn Rd. During the encounter, the accused grabbed the victim from behind before he assaulted her and attempted to drag the victim into a nearby wooded area. A passing motorist stopped to assist, and the parties separated. The victim flagged down a passing officer who was able to quickly detain the accused without incident. Minor injuries were reported. Following the investigation, the accused, identified as a **16-year-old male juvenile**, was arrested.

Malicious Wounding – On November 10 at 5:02PM, officers responded to the 10400 block of Kim Graham Ln in Manassas (20109) to investigate a stabbing. The investigation revealed the victim, a 33-year-old man, and an unknown man, later identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused cut the victim with a knife to his upper body. The parties separated and the police were contacted. The accused remained on scene where he was detained without incident. The victim was transported to an area hospital for treatment of non-life threatening injuries. Following the investigation, the accused, identified as Crisobal Montes Flores **GUEVARA**, was arrested.

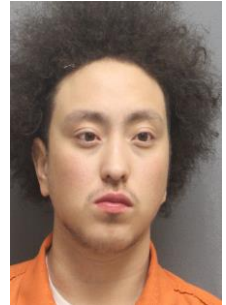

Reckless Handling of a Firearm – On November 9 at 10:47PM, officers responded to a residence located in the 3000 block of Acorn Ct in Woodbridge (22193) to investigate a shots fired call. The investigation revealed a resident of the home, identified as the accused, retrieved a firearm from a vehicle and fired multiple rounds into the air. Neither the firearm nor vehicle belonged to the accused. No injuries or property damage were reported. Following the investigation, the accused, identified as Alvaro Jefferson **GUTIERREZ-ROMERO**, was arrested.

Assault & Battery – On November 7, the School Resource Officer (SRO) assigned to Freedom High School located at 15201 Neabsco Mills Rd in Woodbridge (22191) began an investigation into an assault by a school staff member against a student that reportedly occurred on October 8. The investigation revealed the victim, an 18-year-old female student, was on a bus in the parking lot of the school when she encountered a school security officer, identified as the accused. During the encounter, the accused pinched the victim's cheek while he engaged in an inappropriate conversation. No injuries were reported. The incident recently came to the attention of school officials who notified the police. Following the investigation, the SRO obtained a summons for the accused, identified as Pedro S. **CHIRINO** who was served on November 8.
