Updates

Malicious Wounding (Domestic Related) *ARREST – On November 10, the suspect sought in connection to the stabbing that was reported to have occurred at a residence located in the 1400 block of Maryland Ave. in Woodbridge (22191) on August 19, was arrested. The accused, identified as Valentino **CRUZ REYES**, was taken into custody by the Mecklenburg County Sheriff's Office in North Carolina.

Malicious Wounding (Domestic Related) [Previously Released] – On August 19 at 12:53AM, officers responded to a residence located in the 1400 block of Maryland Ave. in Woodbridge (22191) to investigate a stabbing. The investigation revealed the victims, a 31-year-old woman and a 44-year-old man, were inside the residence when an acquaintance, identified as the accused, entered the home without permission. During the encounter, the accused threatened the male victim and brandished a machete-style knife. The accused struck the male victim with the knife multiple times, including in the face, before physically striking the female. The parties separated and the police were contacted. The male victim was treated at an area hospital for non-life threatening injuries while the female victim reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Valentino **CRUZ REYES**. Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery *ARREST – On November 8, the suspect, identified as Timothy Damon **RUTHERFORD**, who was sought in connection to the robbery that was reported to have occurred at the intersection of Clipper Dr. and Mayflower Dr. in Woodbridge (22192) on October 20, was arrested.

Strong-Arm Robbery [Previously Released] – On October 20 at 10:48PM, officers responded to the intersection of Clipper Dr. and Mayflower Dr. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 13-year-old male juvenile, was approached by two acquaintances. During the encounter, the victim was struck, and his phone was taken before the parties dispersed. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for one of the suspects, identified as Timothy **RUTHERFORD**. Charges for assault were also sought against the other juvenile suspect. Attempts to locate the accused have been unsuccessful.

Incidents

Hit & Run Crash Investigation – On November 11 at 2:13PM, officers responded to the area of Sudley Rd and the I-66 interchange in Manassas (20109) to investigate a hit & crash involving a bicyclist. The investigation revealed the bike rider, identified as a 33-year-old man, was riding within the roadway northbound on Sudley Rd when he was struck by an unknown vehicle. The driver of the striking vehicle did not stop and continued onto I-66 headed east. The cyclist was treated at an area hospital for non-life threatening injuries. Witnesses described the striking vehicle as possible a black Honda Civic with damage to the front left area of the vehicle.

Attempted Commercial Burglary – On November 11 at 8:39AM, officers responded to the Taheri Dental Group located at 3114 Golansky Blvd, #101, in Woodbridge (22192) to investigate an attempted burglary. The investigation revealed sometime between 3:00PM on November 8 and 7:00AM on November 11, forced entry was attempted into the business through a window that was found damaged. No entry was made into the building and no property was reported missing.

Arrests

Assault & Battery on a Law Enforcement Officer [LEO] | Attempt to Disarm – On November 10 at 11:48PM, officers responded to a residence located in the 3500 block of Bath Ct in Woodbridge (22193) to investigate a domestic dispute. During the investigation, one of the parties involved, identified as the accused, was detained for assaulting a family member. While being escorted to a police cruiser, the accused resisted and grabbed an officer before reaching for the officer's service weapon. The officer maintained control of the accused who was then secured. No injuries were reported. Following the investigation, the accused, identified as Vanjalena Nicole **HINES**, was arrested.
