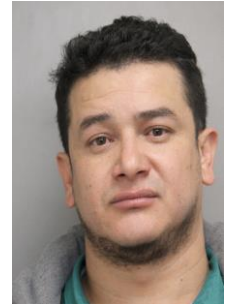
**Rape Investigation \*ARREST** - On November 14, the suspect, identified as Kelvin Johnson **ALVARADO-AGUILAR**, who was sought in connection to the sexual assault that was reported to have occurred at a residence located in the Woodbridge (22191) area of Prince William County in 2023, turned himself into police.

***Arrested on November 14:***

Kelvin Johnson **ALVARADO-AGUILAR**, 36, of the 1300 block of Ironwood St. in Woodbridge

Charged with **rape** and **abduction**

Court Date: **Pending** | Bond: **Held WITHOUT Bond**



**Rape Investigation [Previously Released]** - On October 17, 2024, detectives obtained charges in an ongoing investigation regarding a sexual assault that was reported to have occurred at a residence located in the Woodbridge (22191) area of Prince William County in 2023. The investigation revealed the adult female victim was sexually assaulted by an acquaintance, identified as the accused. While investigating the incident, detectives learned the accused had held the victim against her will in an altercation in 2022. The victim eventually reported the incidents prompting the police investigation. Following the investigation, detectives obtained arrest warrants for the accused, identified as Kelvin Johnson **ALVARADO-AGUILAR**. Attempts to locate the accused have been unsuccessful.

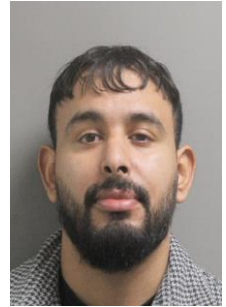
**Malicious Wounding (Domestic) \*ARREST** – On November 13, the suspect, identified as Yovani Anthony **MARTINEZ**, who was sought in connection to the domestic assault that was reported to have occurred at a residence located in the 1500 block of Florida Ave in Woodbridge (22191) on November 8, was arrested.

Charged with ***malicious wounding***

**Malicious Wounding (Domestic) [Previously Released]** – On November 8 at 11:05PM, officers responded to a residence located in the 1500 block of Florida Ave in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 52-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the altercation turned physical, and the victim sustained lacerations to his face. The parties separated and the accused left the area prior to police arriving on the scene. The victim was transported to an area hospital for treatment of non-life threatening injuries. Following the investigation, officers obtained an arrest warrant for the accused, identified as Yovani Anthony **MARTINEZ**. Attempts to locate the accused were unsuccessful.

**Strangulation | Abduction (Domestic)** – On November 13, the suspect, identified as Mohammed Hussein **AL TAMIMI**, who was sought in connection to the domestic assault that was reported to have occurred at a residence located in the 2600 block of Cristina Ct in Woodbridge (22192) on November 9, was arrested.

Charged with 1 count of **strangulation**, 1 count of **abduction**, 1 count of **robbery**, 2 counts of **domestic assault & battery**, and 1 count of **preventing the summoning of law enforcement**

**Strangulation | Abduction (Domestic) [Previously Released]** – On November 9 at 8:22PM, officers responded to a residence located in the 2600 block of Cristina Ct in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 20-year-old woman, and an acquaintance, identified as the accused, were involved in a physical altercation the day prior. During the encounter, the accused put his hands around the victim's neck and forcibly prevented her from leaving the residence. The accused then struck the victim in the face when she attempted to defend herself. The parties eventually separated before a verbal argument escalated the following day. When the victim attempted to call police, the accuse grabbed her phone and left the home. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Mohammed Hussein **AL TAMIMI**. Attempts to locate the accused were unsuccessful.

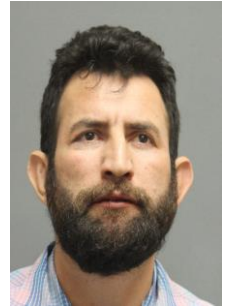

## Incidents

**Burglary while Armed (Domestic)** – On November 13 at 10:50PM, officers responded to the Sudley Crossing Apartments located in the 10800 block of Gambriel Dr in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 35-year-old woman, reported that an acquaintance, identified as the accused, had broken into her apartment through a locked patio door and struck her in the face while armed with a handgun. The accused left the apartment prior to officers arriving on scene. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as David Alejandro **MARCHORRO GUERRA**. Attempts to locate the accused were unsuccessful.

Wanted for 1 count of **burglary while armed**, 1 count of **brandishing of a firearm**, 2 counts of **felony domestic assault & battery**, 1 count of **use of a firearm in commission of a felony**, 1 count of **possession of a firearm by a convicted felon**, and 1 count of **destruction of property**

**Shooting Investigation** – On November 15 at 1:39AM, officers responded to the Summerhouse II Condos located in the 1000 block of Gardenview Lp in Woodbridge (22191) to investigate a shooting. The investigation revealed an 18-year-old man was shot in the lower body and found by responding officers next to a vehicle in the parking lot. The man was treated at an area hospital where the injury was determined to be non-life threatening. The altercation is believed to have occurred in a nearby residence where a shell casing and marijuana were located. The man was not forthcoming with investigators as to what led up to the shooting or the other parties involved. **This incident is not believed to be random.**

**Shooting into a Residential Dwelling** – On November 14 at 8:54PM, officers responded to the Elevations One Apartments located in the 14300 block of Bellona Rd in Woodbridge (22191) to investigate a shots fired call. The investigation revealed several shots were fired in the area resulting in two apartments being struck. No injuries or other property damage were reported. Officers located multiple shell casings.

**Commercial Burglary** – On November 15 at 5:01PM, officers responded to the UniqueSoles located at 2894 Gaber Way in Woodbridge (22192) to investigate a burglary. The investigation revealed the front glass door to the business had recently been broken out. Surveillance video showed four men were involved in the burglary, possibly leaving the area in a maroon sedan with Maryland license plates. Various clothing items and shoes were reported missing.

**Residential Burglary** – On November 14 at 5:28PM, officers responded to a residence located in the 8200 block of Vermont Pl in Manassas (20109) to investigate a burglary. The investigation revealed sometime between 9:00AM and 5:00PM, entry was made into the home by unknown means. An undisclosed amount of money was reported missing.

**Attempted Residential Burglary** – On November 14 at 11:14PM, officers responded to a residence located in the 12200 block of Woodlark Ct in Manassas (20112) to investigate an attempted burglary. The investigation revealed sometime around 8:30PM, a blue Toyota Camry was seen in the homeowner's driveway, and the garage door to the home was found open. The vehicle quickly left the area. No property was reported missing.

**Attempted Residential Burglary** – On November 13 at 3:23PM, officers responded to a residence located in the 14400 block of Filarete St in Woodbridge (22193) to investigate an attempted burglary. The investigation revealed forced entry was attempted into the residence through the front door which was found damaged. The homeowner was present at the time of the incident. No entry was made into the home and no property was reported missing. A police K-9 searched the area for the suspect(s) who were not located.

## Arrests

**Malicious Injury by Caustic Substance** – On November 14 at 8:23AM, officers responded to investigate an assault that was reported to have occurred in the area of Classic Spring Dr and Canova Dr in Manassas (20112) on November 13 around 1:00PM. The investigation revealed the victim, a 38-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused sprayed the victim in the face with an eye irritant. The parties separated and police were contacted the following day. Minor injuries were reported. Following the investigation, the accused, identified as Roger Paul **MONTAQUE**, was arrested.

**Strong-Arm Robbery** – On November 13 at 3:30PM, officers responded to the area of Richmond Hwy and American Eagle Blvd in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 15-year-old male juvenile, was approached by a group of other juvenile acquaintances as he walked in the above area. During the encounter, the group assaulted the victim and took his ski mask while displaying knives. The group dispersed and the victim flagged down a nearby officer to report the altercation. No injuries were reported. Following the investigation, officers identified and obtained charges against three of the involved juveniles.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On November 13 at 6:19PM, officers attempted to detain a suspect at Sephora inside Potomac Mills located at 2700 Potomac Mills Cir in Woodbridge (22192) for shoplifting. During the arrest, the suspect, later identified as the accused, fled on foot and pushed an officer being secured. No injuries were reported. Following the investigation, the accused, identified as Sahir Enrique **ESQUERRE SILVA**, was arrested. A second man was also detained without incident and charged with assisting the accused in the initial theft.

**Assault & Battery** – On November 6, officers began an investigation into an assault by a school staff member against a student that reportedly occurred at Ellis Elementary School located at 10400 Kim Graham Ln in Manassas (20109) on October 29. The investigation revealed the victim, a 3-year-old boy, was inside a classroom when he was struck in the head by the staff member, identified as the accused. The victim reportedly sustained a minor mark to his forehead from the encounter. The incident was reported to school officials who notified the police. Following the investigation, officers obtained a summons for the accused, identified as Sophie Mihyun **CHOI**, who was served on November 14.
