DAILY INCIDENT REPORT

November 18, 2024

Updates

Fatal Crash Investigation *ARREST – On November 13, crash investigators obtained an arrest warrant against the driver involved in the fatal pedestrian crash that occurred in the area of Mapledale Dr. near Miles Ct. in Woodbridge (22193) on October 17. The investigation determined the accused was traveling more than 20 miles per hour (MPH) over the posted speed limit of 25MPH in a residential zone at the time of the collision. A 57-year-old woman who was walking in the area at the time was struck and killed. Following the investigation, the driver, identified as Neil Jostin **STAGNARO RIEGA**, turned himself into police on November 15.

Fatal Crash Investigation [Previously Released] – On October 17 at 6:37AM, officers responded to the area of Mapledale Dr. near Miles Ct. in Woodbridge (22193) to investigate a crash involving a pedestrian. The investigation revealed the driver of a 2020 Nissan Versa was traveling southbound on Mapledale Dr. approaching the intersection with Miles Ct. when the vehicle left the roadway and drove onto the sidewalk striking a pedestrian who was walking her dog. The pedestrian was pronounced deceased on scene. The driver of the striking vehicle remained at the scene and was uninjured. The dog was later located near the pedestrian's residence and was not injured. Investigators determined that alcohol and drugs are not factors for the driver. Charges are pending as the investigation continues.

November 18, 2024

Incidents

Shooting into Residential Dwellings – On November 16 at 1:12PM, officers responded to the 13000 block of Kidwell Dr. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed gunfire was exchanged between a man and the occupants of a white Tesla. During the shooting, rounds struck two separate residences and an occupied vehicle before all parties dispersed. No injuries or additional property damage were reported. Officers located shell casings at the scene.

Armed Robbery – On November 15 at 2:31PM, officers responded to the Sunglasses Hut located inside Potomac Mills at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a robbery. The investigation revealed an unknown man entered the store through an unsecured gate and approached the employee. During the encounter, the suspect took several pairs of sunglasses while holding a knife before leaving the business. No injuries were reported.

Suspect Description:

A black male approximately 5'6" and 180lbs.

Last seen wearing a face mask and all dark-colored clothing

Carjacking – On November 17 at 4:47AM, officers responded to investigate a carjacking that was reported to have occurred in the area of Yorkshire Dr. near Old Centreville Rd. in Manassas (20111) earlier that morning. The investigation revealed the victim, a 27-year-old man, was giving a ride to an unknown man when the man brandished a firearm. The suspect then demanded the victim get out of the vehicle before driving off in the vehicle. No injuries were reported. Later that morning, officers located the vehicle unoccupied on Automotive Dr. The suspect was only described as a black male.

Sexual Assault – On November 16 at 12:34PM, officers responded to the Walmart located at 8386 Sudley Rd. in Manassas (20109) to investigate a sexual assault. The investigation revealed the victim, a 42-year-old woman, was walking in the parking lot when she was approached from behind by an unknown man. During the encounter, the man inappropriately touched the victim before getting into a dark-colored vehicle and leaving the area. No injuries were reported.

Attempted Malicious Wounding – On November 16 at 10:10PM, officers responded to a residence located in the 7800 block of Signal Hill Rd. in Manassas (20111) to investigate an attempted assault. The investigation revealed the victim, a 24-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused brandished a knife towards the victim before the parties separated, and the accused left the residence. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as David **TAPIA.** Attempts to locate the accused have been unsuccessful.

Commercial Burglaries – On November 16 at 5:54AM, officers responded to Glendale Plaza located in the 4300 block of Dale Blvd the in Woodbridge (22193) to investigate burglaries to two businesses. The investigation revealed sometime overnight forced entry was made into Top China and Sister's Hair Braiding through the glass front doors which were shattered. Hair products were reported missing from one business and both businesses reported an undisclosed amount of money missing.

Vandalism on School Grounds – On November 15 at 9:02AM, the School Resource Officer assigned to Colgan High School located at 13833 Dumfries Rd. in Manassas (20112) was notified of a vandalism inside the school. The investigation revealed swastikas and vulgar language were etched onto a bathroom stall door. The drawings did not appear to contain any threats, and no additional markings were reported. School personnel removed the markings.

Vandalism – On November 13 at 10:31AM, officers responded to the 11700 block of Robert E. Lee Dr. in Bristow (20136) to investigate a vandalism. The investigation revealed swastikas and vulgar language were spray painted on the drainage tunnels of a neighborhood pond. The drawings appeared to have been inside the tunnel for some time and did not appear to contain any threat. No additional markings in the area have been reported.

Assault with a Caustic Substance – On November 17 at 8:24PM, officers responded to the Wawa located at 2051 Daniel Stuart Sq. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 56-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused took the victim's bag and sprayed him with an eye-irritant before leaving the area. While checking the area, officers located the accused on Opitz Blvd. where he was detained without incident. The victim was treated at the scene for minor injuries. Following the investigation, the accused, identified as Stacy Lenier **SCOTT**, was arrested.

During the encounter, the accused prevented the victim from leaving the area and assaulted her before the parties eventually separated and the victim left the area. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Dwayne Isaiah **POWELL**, who was located and arrested the following day.

Possession of a Weapon on School Grounds – On November 15 at 7:13AM, the School Resource Officer (SRO) assigned to Unity Reed High School located at 8820 Rixlew Rd. in Manassas (20109) was notified of a student in possession of a weapon. The investigation revealed the bookbag of a student, later identified as the accused, activated the Evolve weapon detection system while the student was attempting to enter the school. School personnel recovered a knife inside the bag and notified the SRO. The SRO determined the knife was not part of any threat to other students or staff. On November 17, following the investigation, the accused, identified as Abraham Alexander **ZUNA DEL CID**, was charged.
