### Incidents

**Strong-Arm Robbery** - On November 18 at 8:38AM, officers responded to the Summerhouse II Condominiums located in the 1900 block of Gableridge Turn in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 48-year-old woman, was sitting inside her vehicle when an unknown man got inside and threatened the victim before grabbing her purse. No injuries were reported. While checking the area, officers located the victim's purse and determined her wallet had been removed.

**Reckless Handling of a Firearm** - On November 18 at 6:15PM, officers responded to the Woodbridge Station Apartments located in the 1500 block of Constellation Pl. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple gunshots were heard in the above area. No injuries or property damage were reported. While checking the area, officers located shell casings behind the apartment building.

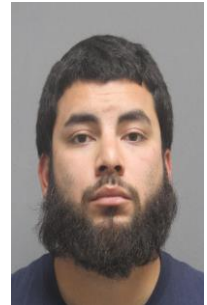

## Arrests

**Malicious Wounding (Domestic Related)** – On November 18 at 12:30AM, officers responded to a residence located in the 10000 block of Brandon Way in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, 22-year-old man, and an acquaintance, identified as the accused, were involved in a physical altercation. During the encounter, the accused struck the victim multiple times before another family member attempted to intervene. Further investigation revealed earlier in the day a 22-year-old woman and the accused were involved in a separate encounter where she was injured. The male victim was transported to an area hospital for treatment of non-life threatening injuries. Following the investigation, the accused, identified as Christopher Gustavo **CABALLERO**, was arrested.

**Abduction** – On November 18 at 7:46PM, officers responded to the 15500 block of Farm Creek Dr. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 20-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim before both parties walked to a nearby apartment complex where the accused then prevented the victim from leaving. Shortly after, a Good Samaritan intervened, and the victim was able to separate from the accused. While checking the area, officers located the accused, who initially provided officers with false identification. Minor injuries were reported. Following the investigation, the accused, identified as John Jeremiah **BAILEY**, was arrested.
