Sexual Assault Investigation – On November 15, the School Resource Officer assigned to Osbourn Park High School located at 8909 Euclid Ave in Manassas (20111) began an investigation into a sexual assault that was reported to have occurred within the school building at the start of the school year. The incident was recently reported to police and school staff prompting the investigation. An adult female student reported she was in a bathroom located near the gym on the first-floor level of the school when an unknown individual entered her stall and sexually assaulted her. The suspect is believed to be a Caucasian or light-skinned individual, unconfirmed gender, with a thin build, approximately 5'8"-5'9". The individual was reported to be wearing an animal costume mask, a dark-colored long-sleeve shirt and unknown color full-length pants at the time of the offense. The incident was reported to have occurred in August during the first two weeks of the 2024-2025 school year.

Sexual Assault Investigation – On August 7 detectives began an investigation into a sexual assault that was reported to have occurred at a residence in the Manassas (20111) area of Prince William County on July 25. The investigation revealed the victim, who was under the age of 12 at the time of the incident, was sexually assaulted by the accused, who was known to the victim. Following the investigation, detectives obtained arrest warrants for the accused, identified as Chalillo Rosalio **PEREZ PEREZ.** Attempts to locate the accused have been unsuccessful.

Sexual Assault Investigation – On November 20, detectives concluded an investigation into the solicitation of a minor that was reported to have occurred in the Manassas (20109) area of Prince William County between October 20 and October 21. The investigation revealed during the above timeframe, the victim, who was under the age of 18 at the time of the offenses, received sexually explicit messages from an acquaintance, identified as the accused, via Snapchat. In addition, the accused arranged to meet with the victim, and while together, the accused sexually assaulted the victim before the parties separated. The victim recently reported the incident to a school counselor who contacted the police.



Following the investigation, the accused, identified as Elias Samuel VARGAS CANAVIRI, was arrested.
