Malicious Wounding *ARREST – On November 22, the suspect sought in connection to the shooting that was reported to have occurred at the La Caverna Bar and Grill located at 18033 Dumfries Shopping Plz. in Dumfries (22026), on March 7, was arrested. The accused, identified as Janbler **TORRES-SANTOS**, was located and apprehended by Weirton police in West Virginia where he will stay incarcerated until extradited to Prince William County.

Malicious Wounding *SUSPECT IDENTIFIED [Previously Released] – On March 28, detectives identified and obtained arrest warrants for the suspect involved in the shooting that was reported to have occurred at the La Caverna Bar and Grill located at 18033 Dumfries Shopping Plz. in Dumfries (22026), on March 7. The suspect, identified as Janbler **TORRES-SANTOS**, has ties to the Culpeper area and is known to drive a black Toyota Tacoma with unknown license plates. Anyone with information on the whereabouts of the suspect is asked to contact police.

Shooting Investigation [Previously Released] – On March 7 at 11:57PM, officers responded to investigate a shooting that was reported to have occurred at La Caverna Bar and Grill located at 18033 Dumfries Shopping Plz. in Dumfries (22026) earlier that evening. The investigation revealed the victim, a 29-year-old man, was involved in a verbal altercation with a group of individuals that escalated in the parking lot of the above location. At one point during the altercation, one of the individuals retrieved a firearm and fired a round striking the victim to the upper body. All parties fled prior to police arriving in the area. The victim was treated at an area hospital where police were contacted. The injury was determined to be non-life threatening. No additional injuries or property damage were reported.

Aggravated Assault (Domestic Related) - On November 24 at 9:09PM, officers responded to the 8300 block of Sudley Rd. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 23-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated inside a vehicle. During the encounter, the accused grabbed the victim's neck and struck her several times before preventing her from leaving the vehicle. Eventually, the parties separated after a Good Samaritan attempted to intervene. The accused took the victim's phone and purse and left the area. The victim was treated at an area hospital for minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Joel **BOBADILLA**. Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery - On November 23 at 5:32AM, officers responded to the 4400 block of Kenwood Dr. in Woodbridge (221913) to investigate a robbery. The investigation revealed the victim, a 23-year-old man, was driving two unknown women and one unknown man in the above area when the man grabbed him from behind while one of the women took his wallet. The woman then took money out of the wallet before the parties separated. No injuries were reported. The suspects were described as two white female wearing grey hooded sweatshirts and one male.

Arrests

Felony Homicide Investigation – On November 22, detectives arrested two individuals in connection to an ongoing investigation involving the criminal neglect of a vulnerable adult which stemmed from a call to the family's home located at the Bayvue Apartments located in the 14100 block of Fisher Ave. in Woodbridge (22191) earlier this year on April 2. The investigation revealed the victim, a 32-year-old man, was being treated at an area medical center suffering from extreme neglect. Medical personnel had responded to the home where the victim, who was immobile due to cerebral palsy, was found unconscious on the floor appearing severely emaciated and in an unkempt state with open wounds to his body. The victim's mother, identified as Katharine Mary **THOMPSON**, was determined to be the victim's primary caregiver, and was previously charged with felony neglect at the time of the initial investigation. On April 15, the victim was declared deceased and transported to the Medical Examiner's Office for an autopsy where it was later determined the manner of death would be classified as a homicide due to *sepsis in the setting of cerebral palsy and neglect*. The victim's brother, identified as Jonathan Lee **THOMPSON**, was also found to have resided with the victim and had assisted in his care at times making him a responsible party. Following the investigation, both accused family members were arrested. **Anyone with information to aid in this investigation is asked to contact the police.**

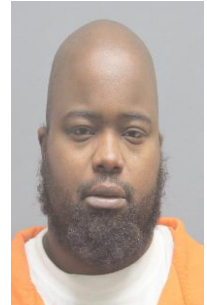

Murder Investigation – On November 23 at 9:09PM, officers responded to 8000 block of Stream Walk Lane in Manassas (20109) to investigate a shooting. Officers arrived on the scene and located the victim, later identified as a 45-year-old man, in the parking lot suffering from multiple gunshot wounds. The victim was pronounced deceased at the scene. The investigation revealed the accused and victim were involved in a physical altercation that escalated. During the encounter, the accused pulled out a firearm and shot the victim multiple times. Police searched the area for the suspect who left the scene and was not initially located. Detectives located the accused early the following morning nearby in the Manassas area, where he was detained without incident. **This incident was not random.** Following the investigation, the accused, identified as Zahir Abdul-Rahman **MUJAHID**, was arrested.

Brandishing of a Firearm – On November 19 at 6:51PM, officers responded to the 7-Eleven located at 8375 Sudley Rd. in Manassas (20109) to investigate a brandishing. The investigation revealed the victim, a 66-year-old man, was approached by an unknown man, later identified as the accused, in the parking lot. During the encounter, the accused brandished a firearm towards the victim before leaving the area. No shots were fired, and no injuries were reported. On November 22, following the investigation, the accused, identified as Roris A. **LAZO LOVO**, was charged while in custody at the Adult Detention Center on unrelated charges.
