Shooting into an Unoccupied Vehicle | Reckless Handling of a Firearm *ARREST – On November 22, 2024, detectives concluded the investigation into the shots fired call that was reported to have occurred in the 13900 block of Rope Dr. in Woodbridge (22191) on August 4, 2023. While investigating the incident, detectives determined there were multiple suspects involved and obtained warrants for their arrest. On November 11, one of the suspects, identified as Bryant Manuel **HENRIQUEZ FLORES**, was arrested and on November 22, the second suspect, identified as Dan Benedict **GALVEZ**, was arrested.

**Continuation from the investigative update on the previous page.*

Shooting into an Unoccupied Vehicle | Reckless Handling of a Firearm [Previously Released] – On August 4 at 10:40PM, officers responded to the 13900 block of Rope Dr. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed the victim, a 50-year-old man, was working on a vehicle parked in the above area, when he was approached by an unknown man. During the encounter, the suspect brandished a firearm and fired multiple rounds towards the victim. The victim was able to flee the area on foot and was not injured. While investigating the incident, officers determined the man was possibly with a group of other men who were near a brown-colored vehicle prior to the encounter. While checking the area, officers located two vehicles that sustained damage consisted with being struck by projectiles, and shell casings in the roadway. No injuries or additional property damage were reported.

Malicious Wounding (Domestic Related) *ARREST – On November 25, the suspect, who was sought in connection to the domestic dispute that was reported to have occurred in the 8300 block of Sudley Rd. in Manassas (20109) on November 24, was arrested. The accused, identified as Joel **BOBADILLA**, was apprehended by members of the U.S. Marshal's Fugitive Task Force in Nashville, Tennessee, where he will stay incarcerated until extradited to Prince William County.

Aggravated Assault (Domestic Related) [Previously Released] – On November 24 at 9:09PM, officers responded to the 8300 block of Sudley Rd. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 23-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated inside a vehicle. During the encounter, the accused grabbed the victim's neck and struck her several times before preventing her from leaving the vehicle. Eventually, the parties separated after a Good Samaritan attempted to intervene. The accused took the victim's phone and purse and left the area. The victim was treated at an area hospital for minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Joel **BOBADILLA**. Attempts to locate the accused have been unsuccessful.

Strangulation (Domestic Related) – On November 22 at 9:40AM, officers responded to a residence located in the 13500 block of Lynn St. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 41-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck. Shortly after the parties separated, the accused took the victim's phone, preventing her from calling emergency services, and left the residence. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Jermaine A. **SIMMS**. Attempts to locate the accused have been unsuccessful.

Commercial Burglary – On November 24 at 8:43PM, officers responded to Beltsville Construction Supply located at 10337 Balls Ford Rd. in Manassas (20109) to investigate an alarm activation. Surveillance footage revealed an unknown man used a tire iron to force entry into the business through the glass front door. While inside the suspect took multiple power tools before leaving in a dark colored sedan. The suspect was described as a male last seen wearing a black hat, a grey hooded sweatshirt, dark-colored pants, and blue shoes.

Attempted Commercial Burglary – On November 24 at 4:52AM, officers responded to All Shooters Tactical located at 3310 Noble Pond Way in Woodbridge (22193) to investigate an alarm activation. The investigation revealed two unknown males shattered the glass door and side windows in an attempt to gain entry into the building. When the suspects could not enter the building, they both left in a red 4-door vehicle. No property was reported missing.

Attempted Residential Burglary – On November 23 at 12:14AM, officers responded to a residence located in the 12900 block of Tonka Ct. in Woodbridge (22193) to investigate an alarm activation. The investigation revealed the homeowners woke to an alarm activation. Upon checking the home, the homeowners located their front door open. Officers determined no entry was made into the residence and no property was reported missing.

Strangulation – On November 25 at 3:30PM, officers responded to investigate an assault that was reported to have occurred in the area of Gerry Ln. near Dale Blvd. in Woodbridge (22192) sometime between January 1 and March 30. The investigation revealed the victim, a 19-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim's neck before the parties separated. The victim reported sustaining minor injuries during the incident and recently reported the incident prompting the police investigation. Assault & Battery on a Law Enforcement Officer [LEO] – On November 24 at 8:37AM, officers responded to the Riverview Park Apartments located in the 14600 block of Colchester Rd. in Woodbridge (22191) to investigate an underage party. Officers located several individuals inside the apartment including a male juvenile, later identified as the accused, who were determined to be intoxicated. When officers attempted to detain the accused, he actively resisted. The accused struck and bit multiple officers before being detained without further incident. No injuries were reported. Assault & Battery on a Law Enforcement Officer [LEO] – On November 22 at 4:14PM, officers responded to a residence located in the 5400 block of Bantry Ct. in Woodbridge (22193) to investigate a domestic dispute. Officers determined one of the involved parties, identified as the accused, assaulted a 29-year-old family member, and when officers attempted to detain him, the accused actively resisted. After a brief struggle where the accused assaulted multiple officers, he was detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Anthony Arturo **CASTRO**, was arrested.
