The suspects, identified as Timothy Damont **RUTHERFORD** and a **17-year-old male juvenile**, were taken into custody between November 8-18. Additionally, officers obtained arrest warrants for a third suspect, identified as Troy Allen **PHILLIPS Jr.** Attempts to locate **PHILLIPS** have been unsuccessful.

The investigation revealed the victim, a 25-year-old woman, and a group of men were involved in a verbal altercation that escalated. The victim was able to maintain possession of her purse and separated from the suspects. The suspects left the business prior to police arriving on scene. Officers and a police K-9 searched the area for the suspects who were not located. Minor injuries were reported.
