Old Business

- Commissioner workgroups shared their recommendations for the Comp Plan

- Amendment. Recommendations were presented for integrating CESMP actions related to buildings, energy, natural resources and adaptation, and transportation
- G Manno provided a board legislative agenda update. The Board presentation was delayed to November 19th and the draft legislative agenda items will be posted publicly a week before.
- G Manno shared an update on Office of Sustainability resource planning. Budget request for FY26 include four positions in the Sustainability office, implementation of electrification of buildings, addressing the energy efficiency backlog, and EV infrastructure.

New Business

- M Jeter presented the draft resolution on high-capacity transit and land use.
- Approval of the draft Land Use Resolution (VOTING RECORD: Motion: E Ward; Second W Beeton; Ayes: by acclamation; Nays: none)
- G Manno provided an update on the JET meeting. An overview of the county's strategic plan was shared along with the school's annual sustainability report. Schools and transportation have been discussing getting a bus to support field trips to landfill. Discussed creating a list for students to learn about environmental career opportunities. Further discussion will be had on potential collaboration for flood resilience.
- M Smyk shared the green building one pager summary that was developed by the Office of Sustainability intern.

- E Ward shared the evaluation of overshoot strategy was published in Natures Magazine and she will share the link with Commissioners.
- W Beeton attended an event and spoke with Senator Tim Kaine regarding Energy Permitting Reform in the Senate. Mentions it has a lot of support.
- P Palistrant announced proposal for extending Omniride routes in areas to help reduce traffic.
- R Freed requested that commissioners should get briefing from county staff on transportation or resilience.
