### Incidents

**Malicious Wounding** – On November 28 at 3:04AM, officers responded to Columbus Grill located at 8349 Centreville Rd. in Manassas (20111) to investigate an assault. The investigation revealed the victim, a 27-year-old man, and two acquaintances, identified as the two accused, were involved in a verbal altercation that escalated in the parking lot. During the encounter, both the accused struck the victim causing him to fall to the ground where the men continued to strike and kick the victim. At one point, one of the men through an unknown object at the victim before the two suspects left in a black Toyota pickup truck. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the two accused, identified as Christopher Osbaldo **AGUIRRE-ARGUETA** and Eric Yovany **MELARA**. Attempts to locate either man have been unsuccessful.

**Brandishing of a Firearm** – On November 28 at 1:04AM, officers responded to the Regency Apartments located in the 9900 block of Shallow Creek Lp. in Manassas (20109) to investigate a brandishing. The investigation revealed two groups of men were involved in a verbal altercation when one of the men brandished a firearm before dispersing. No shots were fired, and no injuries were reported. The armed suspect was described as a black male with dreadlocks wearing all dark-colored clothing.

**Reckless Handling of a Firearm** – On November 27 at 11:25PM, officers responded to the Regency Apartments located in the 9900 block of Shallow Creek Lp. in Manassas (20109) to investigate a shots fired call. The investigation revealed gunshots were heard before multiple men were seen dispersing. No injuries or property damage were reported. Officers and a police K-9 searched the area for the involved parties who were not located. Shell casings were located by the pond near one of the apartment buildings.

**Reckless Handling of a Firearm** – On November 27 at 8:08PM, officers responded to the 15100 block of Georgia Rd. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed gunshots were heard in the above area before an individual was seen leaving in a vehicle prior to police arriving in the area. No injuries or property damage were reported. Shell casings were located in front of a nearby residence.

**Residential Burglary** – On November 28 at 9:03PM, officers responded to a residence located in the 7300 block of James Madison Hwy. in Gainesville (20155) to investigate a burglary. The investigation revealed earlier that evening entry was made into the residence through an unsecured window. An undisclosed amount of money was reported missing.

**Residential Burglary** – On November 27 at 8:40PM, officers responded to a residence located the 4400 block of Daisy Reid Ave. in Woodbridge (22192) to investigate a burglary. The investigation revealed forced entry was made into the home sometime between 5:50PM and 7:15PM through the front door which was found damaged. No property was reported missing.

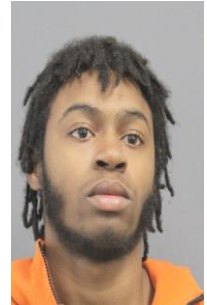

## Arrests

**Murder Investigation** – On November 27 at 8:50PM, officers responded to 13500 block of Delaney Road in Woodbridge (22193) to investigate a domestic dispute. The initial caller reported a domestic altercation involving a family member and then stated gun shots were heard when leaving the residence. Officers arrived on the scene and located the accused, later identified as a 20-year-old man, attempting to leave the residence. The accused was detained without incident. Officers went inside the home and located the victim, later identified as a 20-year-old woman, suffering from a gunshot wound to the upper body. Officers provided aid until the victim was transported to an area hospital where she later succumbed to her injuries. The investigation revealed the accused and victim were in a physical altercation that escalated. During the encounter, the accused retrieved a firearm and shot the victim. Following the investigation, the accused, identified as Anthony Antonio **WHITE** Jr., was arrested.

**Malicious Wounding | Child Neglect** – On November 30 at 1:02AM, officers responded to a residence located in the 14200 block of Clatterbuck Lp. in Gainesville (20155) to investigate a domestic dispute. The investigation revealed the victim, a 57-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. Both parties were in the bedroom with three children, all under the age of 10, when the accused pushed the victim out of the bed causing her to strike the nightstand and lose consciousness. At that point, one of the children contacted emergency services. While investigating the incident, officers determined the accused was intoxicated and unable to properly care for the children. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Eduard **MENDEZ UGARTE**, was arrested.

**Malicious Wounding of a Law Enforcement Officer [LEO]** – On November 30 at 4:48AM, officers responded to a residence located in the 13400 block of Kerrydale Rd. in Woodbridge (22193) to investigate an intoxicated individual. Officers located a man, later identified as the accused, halfway out of a second story window. When officers attempted to detain the accused, he actively resisted and bit an officer. Eventually, officers detained the accused without further incident. Further investigation revealed the accused was in possession of suspected illegal drugs. The officer reported minor injuries. Following the investigation, the accused, identified as Johnny Francisco **FLORES HERNANDEZ**, was arrested.

**Strangulation (Domestic Related)** – On December 1 at 12:01PM, officers responded to the Bayvue Apartments located in the 14100 block of Fisher Ave. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 23-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused shoved the victim before grabbing her neck and brandishing a firearm. The accused further physically prevented the victim from contacting the police. Eventually the parties separated, and the accused damaged a television before leaving the residence. The accused later returned to the residence where he was detained without incident. The victim was treated at the scene for minor injuries. Following the investigation, the accused, identified as Jamal Edwards **HASKINS**, was arrested.



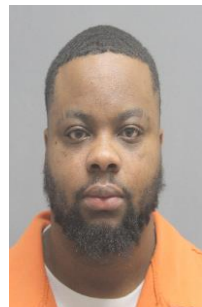

**Sexual Assault Investigation** – On November 22, 2024, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence in the Woodbridge (22191) area of Prince William County sometime between September 2016 and September 2018. The investigation revealed the victim, who was under the age of 13 during the time of the offense, was sexually assaulted by the accused, who was known to the victim. The victim recently reported the incident prompting the police investigation. Following the investigation, the accused, identified as Anthony **BENNETT**, turned himself in to police without incident.

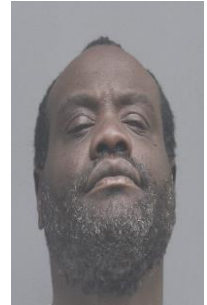

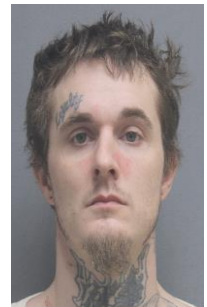

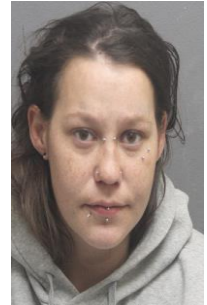
