The investigation revealed the victim, a 32-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused prevented the victim from leaving the room before taking her vehicle and leaving. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Henry Osmin **GARCIA.** Attempts to locate the accused have been unsuccessful.

### **Incidents**

**Armed Robbery –** On December 3 at 4:24PM, officers responded to the 1900 block of Knoll Top Ln. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 14-year-old male juvenile, was approached by two unknown men. During the encounter, one of the men brandished a firearm before demanding the victim's jacket and shoes. The parties separated and the victim left the area to contact the police. No injuries were reported.

**Armed Robbery –** On December 3 at 3:12PM, officers responded to the Home Depot located at 14025 Foulger Sq. in Woodbridge (22192) to investigate a robbery. The investigation revealed security confronted an unknown man attempting to leave the store with unpaid items. During the encounter, the suspect brandished a knife before leaving the area in a vehicle. No injuries were reported. Socks and a powered screwdriver kit were reported missing.

#### Suspect Description:

A Hispanic male, between 18-20 years old, approximately 5'7", with black hair Last seen wearing a blue sweatshirt, gray shorts, and white shoes

**Attempted Commercial Burglary –** On December 4 at 3:46AM, officers responded to King Smoke Palace located at 4166 Dale Blvd. in Woodbridge (22193) to investigate an alarm activation. Video surveillance revealed three males, possibly juveniles, attempted to enter the business by shattering the front glass door with a rock. No entry was made, and the suspects left the area. Officers and a police K-9 searched the area for the suspects who were not located. No property was reported missing. The suspects were described as Hispanic males, wearing ski-style masks and dark-colored clothing.
