Attempted Sexual Assault Investigation *SUSPECT PROFILE – Prince Wiliam County detectives have released a composite sketch of the suspect sought in connection to the attempted sexual assault that was reported to have occurred at Nokesville Community Park located at 12560 Aden Rd in Nokesville (20181) on December 10 around 9:00AM. The suspect is believed to be a white or light-skinned male, around 5'9" with an average build, brown eyes, and dark bushy eyebrows. The suspect was reportedly last seen wearing all dark-colored clothing including a long-sleeve shirt made from dry-wicking material, sweatpants, and a ski-style mask only exposing his eyes. The investigation continues.



Attempted Sexual Assault Investigation [Previously Released] – On December 10 at 9:37AM, officers responded to Nokesville Community Park located at 12560 Aden Rd in Nokesville (20181) to investigate a reported attempted sexual assault. The investigation revealed the victim, an adult woman, was walking along a trail in the park near Hickerson Ln. when she was approached by a masked man. During the encounter, the man attempted to sexually assault the victim. A struggle ensued and the parties eventually separated. Another park patron located the victim and assisted her in contacting police. The victim was treated at the scene for minor injuries. Officers and a police K-9 searched the area for the suspect who was not located. At this time, the suspect is only described as a male wearing a mask. It is currently unknown if the victim and suspect were known to one another. The investigation continues.

Strangulation | **Abduction (Domestic) *ARREST** – On December 10, the suspect, identified as Ta-equan Marquis **HILL**, who was sought in connection to the assault that was reported to have occurred in the 7500 block of Purdue Ct in Manassas (20109) on November 5, was arrested.

Strangulation | Abduction (Domestic) [Previously Released] – On November 5 at 11:38AM, officers responded to investigate an assault that was reported to have occurred at a residence located in the 7500 block of Purdue Ct in Manassas (20109) earlier that morning. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused physically assaulted the victim, and at one point, grabbed her by the neck after he took the victim's phone when she attempted to call police. The suspect also precented the victim from leaving the residence. The parties eventually separated, and the victim left the home to contact police. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Ta-equan Marquis **HILL**. Attempts to locate the accused were unsuccessful.

Incidents

Brandishing a Firearm – On December 11 at 9:06PM, officers responded to the area of Linton Hall Rd near Devlin Rd in Gainesville (20155) to investigate a road rage encounter. The investigation revealed the victim, a 27-year-old man, was involved in a road rage incident with the driver of another vehicle while both vehicles were traveling along Linton Hall Rd. During the encounter, the other driver brandished a firearm before the parties separated. No shots were fired, and no injuries were reported. Officers are following up on a potential suspect involved.

Brandishing a Firearm – On December 10 at 1:35PM, officers responded to investigate a road rage encounter that was reported to have occurred along Legend Glen Dr in Gainesville (20155) earlier that afternoon. The investigation revealed the victim, a 41-year-old man, was involved in a road rage incident with the driver of another vehicle while both vehicles were stopped at a stop sign along Legend Glen Dr. During the encounter, the other driver brandished a firearm before the parties separated. No shots were fired, and no injuries were reported. Officers are following up on a potential suspect involved.

Indecent Exposure – On December 11 at 8:17AM, officers responded to the area of Anderson Ct and Arkendale St in Woodbridge (22193) to investigate an indecent exposure. The investigation revealed the victim, a 23-year-old woman, was driving on Anderson Ct when she observed an unknown man expose himself and make inappropriate gestures. No other contact was made between the victim and the suspect. Officers checked the area for the suspect who was not located. The suspect was only described as a black male in his early-mid 30s.

Vandalism on School Grounds – On December 11 at 9:57AM, the School Resource Officer assigned to Patriot High School located at 10504 Kettle Run Rd in Nokesville (20181) was notified of vandalism at the school. The investigation revealed a swastika and other inappropriate images were drawn on a partition inside a classroom. The drawings did not appear to contain any threats towards students or staff, and no additional markings were reported.
