Incidents

Fatal Crash Investigation – On December 15 at 8:41PM, crash investigators responded to the area of Dale Blvd. near Kirkdale Dr. in Woodbridge (22193) to investigate a single vehicle crash. The investigation revealed the driver of a 2013 Ford Focus was traveling westbound on Dale Blvd. when the vehicle traveled off of the roadway and into the left-side median after passing Kirkdale Dr. The vehicle then continued along the grassy median for a short distance before striking a tree and coming to rest. The driver of the vehicle was transported to an area hospital where he later died. No other occupants were inside the vehicle. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

The deceased driver of the 2013 Ford Focus was identified as Dillon Grier **HARLOW**, 25, of Woodbridge

Shooting Investigation – On December 14 at 3:30PM, officers responded to the 16000 block of Hayes Ln. in Woodbridge (22191) to investigate a shooting. The investigation revealed a 21-year-old man had been shot in the upper body and was found lying near the side of the roadway by responding officers. The man refused to cooperate further with the investigation and was treated at an area hospital for injuries determined to be non-life threatening. No additional injuries or property damage were reported.

Aggravated Assault – On December 13 at 10:17PM, officers responded to the Stonebridge at Potomac Town Center located at 15200 Potomac Town Pl. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 17-year-old male juvenile, was approached from behind by two unknown males, possibly juveniles. During the encounter, the suspects struck the victim causing him to fall to the ground where they continued to assault the victim before leaving the area. The victim was treated at an area hospital for non-life threatening injuries where the police were contacted.

Armed Robbery – On December 14 at 9:01PM, officers responded to Ross located at 10822 Sudley Manor Dr. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 29-year-old woman, was getting into her vehicle when an unknown man opened the passenger side door. During the encounter, the suspect brandished a firearm and demanded money. The suspect took the victim's wallet before leaving the area. The victim also left the area before contacting the police. No injuries were reported. The suspect was described as a short darker-skinned male, with a heavy build and last seen wearing a black ski-style mask, dark-colored clothing, and carrying a backpack.

Brandishing of a Firearm - On December 15 at 5:10PM, officers responded to the area of Richmond Hwy. near River Ridge Blvd. in Dumfries (22026) to investigate a brandishing. The investigation revealed the victim, a 44-year-old woman, was driving in the above area when she was involved in a road rage incident with the driver of a white Toyota sedan. During the encounter, the other driver brandished a firearm before the parties separated. No shots were fired, and no injuries were reported. The driver was last seen wearing a black ski-style mask.

Brandishing of a Firearm – On December 12 at 11:07PM, officers responded to the 16800 block of Richmond Hwy. in Dumfries (22026) to investigate a brandishing. The investigation revealed the victim, a 43-year-old man, and another man, later identified as the accused, were involved in a verbal altercation that escalated in a parking lot. During the encounter, the accused brandished a firearm towards the victim before the parties separated and the victim contacted the police. Following the investigation, officers obtained arrest warrants for the accused, identified as Charles Lindbergh **LEACH**. Attempts to locate the accused have been unsuccessful.

Strangulation (Domestic Related) – On December 15 at 7:56PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 15300 block of Tina Ln. in Woodbridge (22193) on December 14. The investigation revealed the victim, a 33-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused held a knife and pushed the victim onto the bed before grabbing her neck. The parties eventually separated. Minor injuries were reported. Following the investigation, the accused, identified as Robert Dean **THOMAS**, was arrested.

During processing at the Adult Detention Center, the accused spat on the officer before being resecured without further incident. No injuries were reported. Following the investigation, the accused, identified as Jimmy MALDONADO, was arrested.

The investigation revealed the victim, a 4-year-old girl, was located by a Good Samaritan alone inside a vehicle in the parking lot.
