Incidents

Attempted Malicious Wounding – On December 17 at 7:28PM, officers responded to the Broadstone at River Oaks Apartments located in the 3100 block of Chesapeake Dr. in Dumfries (22026) to investigate a domestic dispute. The investigation revealed the victim, a 42-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated in the parking lot. During the encounter, the accused struck the victim when she reached inside his vehicle. The accused then grabbed onto the victim and began driving the vehicle, dragging her for a short distance before she fell to the ground. The accused then left the area. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Derrick Raynaun **JACKSON**. Attempts to locate the accused have been unsuccessful.

Bomb Threat Investigation – On December 17 at 7:01AM, officers responded to the 11500 block of Hayden Rd. in Manassas (20109) to investigate a bomb threat. The investigation revealed an employee of a construction site observed a threat written on the door of a portable bathroom. The building was evacuated as a precaution. Officers determined there was no credible threat to the building. No additional markings or threats were located.

Arrests

Rape Investigation – On December 10, 2024, detectives concluded an investigation into a sexual assault that was reported to have occurred in the Woodbridge (22192) area of Prince William County in July 2023. The investigation revealed the victim, who was under the age of 13 at the time of the offense, met the accused via Snapchat and began a relationship. In July 2023, the accused met the victim at her residence where she was sexually assaulted. The victim reported the incident to family members who contacted the police. While investigating the incident, detectives obtained arrest warrants for the accused, identified as Christopher **GARCIA MORENO**, who was arrested without incident on December 10, 2024.

Strangulation (Domestic Related) – On December 17, officers and Child Protective Services concluded an investigation into a domestic dispute that was reported to have occurred at a residence located in the 14700 block of Keavy Ridge Ct. in Haymarket (20169) on December 15. The investigation revealed the victim, a 13-year-old female juvenile, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her by the neck. Other occupants of the home eventually separated the parties. On December 16, the victim reported the incident to school personnel who contacted the police. Minor injuries were reported. Following the investigation, the accused, identified as Jamon Dieonize **CARTER**, was arrested.
