### Updates

**Murder Investigation \*ADDITIONAL ARRESTS** – While continuing to investigate the fatal shooting that occurred in the 8000 block of Stream Walk Lane in Manassas (20109) on November 23, detectives identified three additional suspects involved in the incident and obtained warrants for their arrests. Between December 13 and 18, the suspects, identified as Ravyn Simone **TIDWELL**, Tazwell Nathaniel **BLANKENBAKER**, and Nicholas Aaron **ROJESKI** were arrested without incident. An additional suspect was previously arrested in November in connection to the investigation.

**Murder Investigation [Previously Released]** – On November 23 at 9:09PM, officers responded to 8000 block of Stream Walk Lane in Manassas (20109) to investigate a shooting. Officers arrived on the scene and located the victim, later identified as a 45-year-old man, in the parking lot suffering from multiple gunshot wounds. The victim was pronounced deceased at the scene. The investigation revealed the accused and victim were involved in a physical altercation that escalated. During the encounter, the accused pulled out a firearm and shot the victim multiple times. Police searched the area for the suspect who left the scene and was not initially located. Detectives located the accused early the following morning nearby in the Manassas area, where he was detained without incident. **This incident was not random.** Following the investigation, the accused, identified as Zahir Adbul-Rahman **MUJAHID**, was arrested.

## Incidents

**Brandishing of a Firearm | Road Rage Related** – On December 18 6:44PM, officers responded to the area of James Madison Hwy. and Logmill Rd. in Haymarket (20169) to investigate a brandishing. The investigation revealed the victim, a 36-year-old man, was involved in a road rage incident with the driver of another vehicle while both vehicles were traveling on James Madison Hwy. While stopped at the above intersection, the other driver brandished a firearm before the parties separated. No shots were fired, and no injuries were reported. The suspect was only described as a white female wearing a hat.

## Arrests

**Felony Child Neglect** – On December 17 at 9:58AM, officers responded to the Elevations One Apartments located in the 14300 block of Jeffries Rd. in Woodbridge (22191) to investigate suspected drug activity. While investigating the incident, officers determined a resident of an apartment, identified as the accused, was in possession of suspected illegal drugs that were also packaged for distribution. Officers also determined the accused was in the care of her 1-year-old daughter at the time. The child was unharmed and released to the custody of known parties. Following the investigation, the accused, identified as Mia Lisia **GUTHRIE**, was arrested. Additional arrests were also made in connection to the investigation.

**Indecent Exposure** – On December 18 at 4:23PM, officers responded to the 10000 block of Lomond Dr. in Manassas (20109) to investigate an indecent exposure. The investigation revealed the victims, a 13-year-old female juvenile and a 32-year-old man, observed a partially unclothed man, later identified as the accused, exposing himself in the above area. Officers located the accused nearby and detained him without incident. No physical contact occurred between the victims and the accused. Following the investigation, the accused, identified as Michael Scott **JENKINSON**, was arrested.
