Updates

Fatal Crash Investigation *WANTED SUSPECT – On December 11, investigators with the Crash Investigation Unit obtained arrest warrants against the driver of a vehicle involved in the fatal collision that occurred in the area of Bristow Rd. near Windy Hill Dr. in Nokesville (20181) on August 28. The investigation revealed the driver of the 2021 Toyota Tundra, identified as the accused, had a blood alcohol content (BAC) level above the legal limit on the day of the crash. The resulting crash killed a 63-year-old Nokesville man. Attempts to locate the accused, identified as James Francis **BYRD**, have been unsuccessful.

The deceased driver of the 2003 Lexus GX was identified as Thomas Spencer **STARK**, 63, of Nokesville

Fatal Crash Investigation [Previously Released] – On August 28 at 6:24PM, officers responded to the area of Bristow Rd. near Windy Hill Dr. in Nokesville (20181) to investigate a crash. The investigation revealed the driver of a 2021 Toyota Tundra was traveling eastbound on Bristow Rd. when the vehicle crossed over the center line and into the westbound lane of travel striking a 2003 Lexus GX in a head-on collision. The impact of the crash caused the Lexus to spin off of the roadway and come to a rest in the ditch while the Tundra remained on the roadway. The driver and sole occupant of the Lexus was transported to an area hospital where he died from injuries sustained in the collision. The driver and sole occupant of the Tundra was transported to an area hospital for minor injuries. Investigators determined that speed, was not a factor for the driver of the Tundra. The investigation continues.

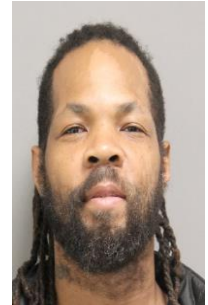

Attempted Malicious Wounding *ARREST – On December 19, the suspect, identified as Derrick Raynaun **JACKSON**, who was sought in connection to the attempted assault that was reported to have occurred at the Broadstone at River Oaks Apartments located in the 3100 block of Chesapeake Dr. in Dumfries (22026) on December 17, turned himself in to police without incident.

Attempted Malicious Wounding [Previously Released] – On December 17 at 7:28PM, officers responded to the Broadstone at River Oaks Apartments located in the 3100 block of Chesapeake Dr. in Dumfries (22026) to investigate a domestic dispute. The investigation revealed the victim, a 42-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated in the parking lot. During the encounter, the accused struck the victim when she reached inside his vehicle. The accused then grabbed onto the victim and began driving the vehicle, dragging her for a short distance before she fell to the ground. The accused then left the area. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Derrick Raynaun **JACKSON**. Attempts to locate the accused have been unsuccessful.

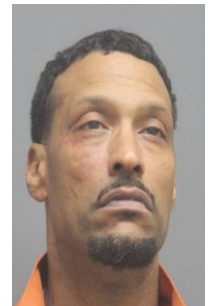

Incidents

Strong-Arm Robbery – On December 19 at 6:15PM, officers responded to the ABC store located at 2231 Old Bridge Rd. in Woodbridge (22192) to investigate a robbery. The investigation revealed an unknown man entered the store, yelled at an employee and then took multiple bottles of alcohol before leaving the store. No injuries were reported. The suspect was described as a Hispanic male with black hair, full beard and mustache and wearing all black clothing.

Arrests

Strangulation (Domestic Related) – On December 18 at 8:51PM, officers responded to a residence located in the 1800 block of Giles Ct. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed three women, all between 22-44 years old, and a male acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck two of the women, before grabbing the neck of the 44-year-old woman, whose phone he also damaged during the encounter. The parties eventually separated. Minor injuries were reported. Following the investigation, the accused, identified as Luther Stephen **GORDON**, was arrested.
