Fatal Crash Investigation *DECEASED IDENTIFIED – On December 27, the driver involved in the fatal crash that occurred in the area of Lake Jackson Dr. near Blandsford Dr. in Manassas (20111) on December 21, was identified. The driver, and sole occupant of the 2017 Volkswagen Golf GTI, was identified as a 21-year-old man. The investigation revealed the deceased was traveling more than double the posted 35MPH speed limit just prior to the collision. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

Fatal Crash Investigation [Previously Released] – On December 21 at 11:51PM, officers responded to the area of Lake Jackson Dr. near Blandsford Dr. in Manassas (20111) for a single vehicle crash. The investigation revealed the driver of a 2017 Volkswagen Golf GTI was traveling northbound on Lake Jackson Dr. when the vehicle veered to the right and left the roadway. The vehicle continued into a field where it struck a utility pole causing the vehicle to flip over several times and eventually catch fire. The driver of the vehicle was not wearing a seatbelt and was pronounced deceased at the scene. No additional vehicles were involved in the crash. Speed is a factor in the crash. The driver of the vehicle was transported to the Medical Examiner's Office for identification. The identity of the deceased will be released once confirmed and a next-of-kin has been notified. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**
