Incidents

Aggravated Assault - On January 1 at 11:16PM, officers responded to the 14000 block of Roanoke St in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 36-year-old man, was assaulted by two men who struck him in the with a glass bottle during a gathering at the residence. The parties separated. The victim was treated at an area hospital for non-life threatening injuries. The two assailants were described as males, possibly Hispanic, both reportedly in the 30s. No further suspect descriptions are available at this time.

Aggravated Assault - On December 31 at 11:43AM, officers responded to the area of the Prince William Pkwy and Shoppers Best Way in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 73-year-old woman, was assaulted by a man who struck her in the face before pushing her to the ground where she then hit her head. The parties separated. The victim was treated at an area hospital for non-life threatening injuries.

Suspect Description:

White male, 50s, approx. 6'1", thin build, and short gray hair

Last seen wearing a dark-colored clothing including a jacket and jeans

Commercial Burglary - On December 31 at 11:45AM, officers responded to ACE Deconstruction located at 13804 Dawson Beach Rd in Woodbridge (22191) to investigate a burglary. The investigation revealed forced entry was made onto the property and into several storage containers around 11:30PM on December 30. Cameras showed an unknown man wearing a gray hooded sweatshirt and dark-colored pants cut a hole in an exterior fence. A power tool was reported missing. No further suspect description is available at this time.

Commercial Burglary - On December 31 at 1040AM, officers responded to the Montclair County Club and Golf Course located at 16500 Edgewood Dr in Dumfries (22025) to investigate a burglary. The investigation revealed forced entry was made into the building sometime between 6:00PM and 7:00PM on December 30 through vent which had been pried open. The individual also made entry into a pool house on the property through an unsecured door. No property was reported missing. No further suspect description is available at this time.

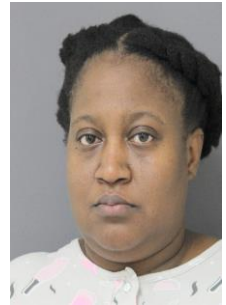

Malicious Wounding (Domestic) – On December 31 at 11:53PM, officers responded to the Coverstone 4 Apartments located in the 7600 block of Cass Pl in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim and pulled out her hair. The parties eventually separated. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Kristy **CUTHBERSTON**, was arrested.
