### Updates

**Fatal Crash Investigation \*ARREST –** On January 8, 2025, the suspect, identified as James Francis **BYRD**, who was sought in connection to the fatal crash that occurred in the area of Bristow Rd. near Windy Hill Dr. in Nokesville (20181) on August 28, 2024, was arrested.

**Fatal Crash Investigation \*WANTED SUSPECT [Previously Released] –** On December 11, investigators with the Crash Investigation Unit obtained arrest warrants against the driver of a vehicle involved in the fatal collision that occurred in the area of Bristow Rd. near Windy Hill Dr. in Nokesville (20181) on August 28. The investigation revealed the driver of the 2021 Toyota Tundra, identified as the accused, had a blood alcohol content (BAC) level above the legal limit on the day of the crash. The resulting crash killed a 63-year-old Nokesville man. Attempts to locate the accused, identified as James Francis **BYRD**, have been unsuccessful.

**Fatal Crash Investigation** [**Previously Released**] – On August 28 at 6:24PM, officers responded to the area of Bristow Rd. near Windy Hill Dr. in Nokesville (20181) to investigate a crash. The investigation revealed the driver of a 2021 Toyota Tundra was traveling eastbound on Bristow Rd. when the vehicle crossed over the center line and into the westbound lane of travel striking a 2003 Lexus GX in a head-on collision. The impact of the crash caused the Lexus to spin off of the roadway and come to a rest in the ditch while the Tundra remained on the roadway. The driver and sole occupant of the Lexus was transported to an area hospital where he died from injuries sustained in the collision. The driver and sole occupant of the Tundra was transported to an area hospital for minor injuries. Investigators determined that speed, was not a factor for the driver of the Tundra. The investigation continues.

**Strong-Arm Robbery \*ARREST –** On January 3, 2025, officers identified the suspect sought in connection to the robbery that was reported to have occurred at the ABC store located at 2231 Old Bridge Rd in Woodbridge (22192) on December 24, 2024. While investigating the incident, officers determined the suspect was also involved in previous shopliftings from the same store between November 6 and December 24, 2024. Following the investigation, officers obtained arrest warrants for the suspect, identified as Jamie Machuchi **ALVARADO**, who was arrested without incident on January 3.

**Strong-Arm Robbery [Previously Released] –** On December 24 at 4:48PM, officers responded to the ABC Store located at 2231 Old Bridge Rd in Woodbridge (22192) to investigate a robbery. The investigation revealed a store employee attempted to stop a patron who was attempting to take unpaid merchandise. A physical altercation ensued before the suspect was able to leave the store with two bottles of alcohol. Officers checked the area for the suspect who was not located. The suspect was described as a Middle Eastern male in his 30s, approximately 5'7" with a slim build wearing a dark-colored jacket overtop a dark-colored sweatshirt, and carrying a dark blue backpack.

**Aggravated Assault –** On January 7 at 12:43AM, officers responded to a residence located in the 1500 block of Katherine Ct. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 47-year-old man, woke to an individual assaulting him. After a brief struggle, the parties separated, and the police were contacted. The victim was treated at an area hospital for non-life threatening injuries. **The incident was not random** and the investigation continues.

**Armed Robbery –** On January 3 at 12:57PM, officers responded to investigate a robbery that was reported to have occurred in the 3100 block of River Heritage Blvd. in Dumfries (22026) earlier that afternoon around 11:30AM. The investigation revealed the victim, a 17-year-old male juvenile, was approached by three unknown individuals in a wooded area near the above location. During the encounter, one of the individuals brandished a knife and demanded the victim's jacket before the suspects left the area. No injuries were reported. The victim reported the incident to a family member later that day who contacted the police. The suspects were described as being between 18-25 years old, wearing all dark-colored clothing.

**Commercial Burglary –** On January 4 at 1:20PM, officers responded to Jersey Mikes located at 3282 Old Bridge Rd. in Woodbridge (22192) to investigate a burglary. The investigation revealed entry was made onto the business through a rear door around 11:10PM on January 3. Cameras showed an unknown man wearing dark-colored clothing and a mask inside the business. The tip jar containing an undisclosed amount of money was reported missing. No further suspect description is available at this time.

**Commercial Burglary –** On January 3 at 9:25AM, officers responded to Thrift Lordes located at 7551 Centreville Rd. in Manassas (20111) to investigate a burglary. The investigation revealed forced entry was made onto the business through a front window around 9:45PM on January 2. Cameras showed an unknown man with a full beard and mustache and wearing a hooded sweatshirt inside the business. Miscellaneous merchandise and an undisclosed amount of money were reported missing.



**Attempted Burglary to a Place of Worship** – On January 3 at 8:46AM, officers responded to investigate an attempted burglary that was reported to have occurred at the McLean Bible Church located at 10002 Battleview Pkwy in Manassas (20109) on December 31 around 2:30AM. The investigation revealed an unknown man attempted to gain entry into two vehicles in the parking lot and the church building, all of which were secured. No entry was made into the vehicles, nor the building and no property was reported missing.

**Assault & Battery on a Law Enforcement Officer [LEO] –** On January 7 at 6:04PM, officers in the area of Bel Air Rd. and Saxophone Way in Woodbridge (22191) made contact with the occupants of a vehicle parked in the roadway. During the encounter, officers observed an occupant, later identified as the accused, in possession of suspected illegal drugs. When officers attempted to detain the accused, and struggle ensued, and the accused kicked multiple officers before being detained without further incident. No injuries were reported by the officers. Following the investigation, the accused, identified as William Lavon **LAMBERT**, was arrested.
