# **DAILY INCIDENT REPORT**

### **Incidents**

Homicide Investigation – On January 9 at 6:19PM, officers responded to the 8300 block of Sunset Dr. in Manassas (20110) to investigate a shooting. When officers initially arrived in the above area, there were no signs of injuries, and any involved parties had left the area. While investigating the incident, officers received information that a 22-year-old man was being treated at an area hospital for gunshot wounds. Further investigation revealed two groups were involved in an altercation that escalated while in the above area. During the encounter, gunfire was exchanged before the parties left the area in separate vehicles. The injured man was driven to an area hospital where he later died. No additional injuries or property damage were reported. This incident does not appear random. Detectives are actively investigating the incident to determine what led up to the shooting. More information will be released when available. ### **Arrests**

**Strangulation [Domestic] -** On January 8 at 7:51PM, officers responded to a residence located in the 8100 block of Leland Rd. in Manassas (20111) to investigate a domestic dispute. The investigation revealed the victim, a 45-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck. The parties eventually separated, and the police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Juan **VELASCO PEREZ**, was arrested.

**Attempted Malicious Wounding [Domestic] -** On January 8 at 10:31PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence in the 10200 block of Farragut Ct. in Manassas (20109) on January 7. The investigation revealed the victim, a 34-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim before, at one point, attempting to stab her with a knife as their 3-year-old daughter was nearby. Eventually, the victim and child left the residence. The victim reported minor injuries. The child was unharmed. Following the investigation, the accused, identified as Eliseo **ZONIGA**, was arrested.
