

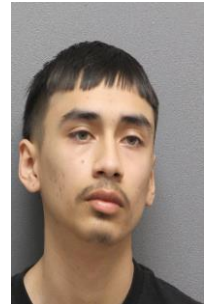


DAILY INCIDENT REPORT

Updates

Murder Investigation | SUSPECT WANTED – During the ongoing investigation into the murder of a 22-year-old man killed in a shooting that occurred in the 8300 block of Sunset Dr. in Manassas (20110) on January 9, detectives have obtained an arrest warrant for a man involved in the encounter. The investigation revealed the victim was fatally shot during an altercation with the accused, identified as Marlon Osvaldo **BAUTISTA**. Attempts to locate **BAUTISTA** have been unsuccessful. **Anyone with information on the whereabouts of the wanted suspect or who can otherwise aid in the investigation is asked to contact the police. More information will be released when available. The investigation continues.**

Homicide Investigation [Previously Released] – On January 9 at 6:19PM, officers responded to the 8300 block of Sunset Dr. in Manassas (20110) to investigate a shooting. When officers initially arrived in the above area, there were no signs of injuries, and any involved parties had left the area. While investigating the incident, officers received information that a 22-year-old man was being treated at an area hospital for gunshot wounds. Further investigation revealed two groups were involved in an altercation that escalated while in the above area. During the encounter, gunfire was exchanged before the parties left the area in separate vehicles. The injured man was driven to an area hospital where he later died. No additional injuries or property damage were reported. **This incident does not appear random.** Detectives are actively investigating the incident to determine what led up to the shooting. Incidents

Shooting into a Residential Dwelling – On January 11 at 10:21AM, officers responded to investigate a destruction of property that was reported to have occurred at a residence located in the 12100 block of Breckinridge Ln. in Woodbridge (22192) sometime overnight. The investigation revealed the homeowner woke to a loud noise and located damage to a window and inside the home later that morning. No injuries or additional property damage were reported.

Armed Robbery – On January 11 at 5:00PM, officers responded to Round 1 Bowling and Amusement inside Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, was approached by three unknown young males, possibly juveniles. During the encounter, one of the suspects brandished a knife while another suspect took the victim's bag before the suspects left the area on foot. No injuries were reported. The suspects were described as Hispanic males wearing all dark-colored clothing.

Armed Robbery – On January 10 at 4:42PM, officers responded to the 14700 block of Cloverdale Rd. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 34-year-old man, arranged to sell a necklace to an unknown individual via Facebook Marketplace. Before the exchange was completed, the other party, grabbed the necklace while brandishing a firearm. The suspect then left the area in a vehicle. No injuries were reported. The suspect was described as a black male, wearing a black surgical-style mask, dark-colored clothing and white tennis shoes.

Commercial Burglary – On January 9 at 5:15PM, officers responded to Mattress Warehouse located at 2680 Opitz Blvd. in Woodbridge (22191) to investigate a burglary. The investigation revealed entry was made into the building around 8:00AM through an unsecured door. Cameras showed the suspect take several items from inside the store before leaving. The suspect was described as a black male, wearing a black Salvation army fitted cap, jacket, a red/white plaid shirt and jeans

Residential Burglary – On January 10 at 8:46AM, officers responded to a residence located in the 7500 block of Old Carolina Rd. in Gainesville (20155) to investigate a burglary. The investigation revealed a neighbor confronted three unknown individuals who were observed attempting to load bags into a vehicle parked in the driveway. The suspects quickly left the area in a black Acura sedan. Clothing items were reported missing. The suspects were described as a white woman in her 60's, with white hair, and two white men between 20-30 years old.

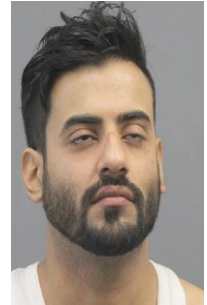

Arrests

Malicious Wounding [Domestic] – On January 11 at 8:31PM, officers responded to the 7500 block of Broken Branch Ln. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times before grabbing her neck. The parties were eventually separated by other parties. The victim was treated at an area hospital for non-life threatening injuries. While investigating the incident, officers determined the victim and the accused were involved in a similar physical altercation the previous day. Following the investigation, the accused, identified as Harnaik Singh **VIRK**, was arrested.

Malicious Wounding – On January 10 at 5:47PM, officers responded to a residence located in the 4400 block of Bunker Ct. in Dumfries (22025) to investigate an assault. The investigation revealed the victim, a 19-year-old man, was physically assaulted by another occupant of the home, identified as the accused, who has entered his room. During the encounter, the accused struck the victim multiple times with a metal coat hanger. The parties were eventually separated by other parties. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Austin **BENDER**, was arrested.

Armed Robbery – On January 11 at 1:41PM, officers responded to Walmart located at 17041 Richmond Hwy. in Dumfries (22026) to investigate a robbery. The investigation revealed a store employee observed the accused conceal merchandise before leaving the store where he was confronted by an employee. During the encounter, the accused brandished a knife before leaving the area. No injuries were reported. Later that day, the accused was identified and detained without incident. No injuries were reported. Following the investigation, the accused, identified as Orlando Jacob **BARRETT**, was arrested.

Strangulation [Domestic] | Assault & Battery on a Law Enforcement Officer [LEO] –

On January 12 at 3:25AM, officers responded to The Landings at Markham's Grant Apartments located in the 2600 block of Penbury Ct. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 40-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim before grabbing her neck. The victim was eventually able to separate from the accused and contact a family member who notified the police. When officers attempted to detain the accused, he actively resisted and assaulted officers before being detained without further incident. The victim reported minor injuries. Following the investigation, the accused, identified as Ethan William **BROMMER**, was arrested. The accused was also found in possession of a suspected illegal drugs.
