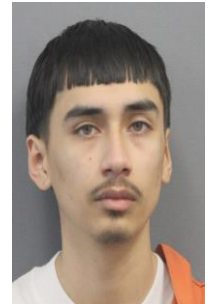
Murder Investigation *ARREST – On January 13, the suspect, identified as Marlon Osvaldo **BAUTISTA**, who was sought in connection to the shooting that killed a 22-year-old man in the 8300 block of Sunset Dr. in Manassas (20110) on January 9, was arrested.

Murder Investigation | SUSPECT WANTED [Previously Released] – During the ongoing investigation into the murder of a 22-year-old man killed in a shooting that occurred in the 8300 block of Sunset Dr. in Manassas (20110) on January 9, detectives have obtained an arrest warrant for a man involved in the encounter. The investigation revealed the victim was fatally shot during an altercation with the accused, identified as Marlon Osvaldo **BAUTISTA**. Attempts to locate **BAUTISTA** have been unsuccessful. **Anyone with information on the whereabouts of the wanted suspect or who can otherwise aid in the investigation is asked to contact the police. More information will be released when available. The investigation continues.**

**Continuation from the investigative update on the previous page.*

Homicide Investigation [Previously Released] – On January 9 at 6:19PM, officers responded to the 8300 block of Sunset Dr. in Manassas (20110) to investigate a shooting. When officers initially arrived in the above area, there were no signs of injuries, and any involved parties had left the area. While investigating the incident, officers received information that a 22-year-old man was being treated at an area hospital for gunshot wounds. Further investigation revealed two groups were involved in an altercation that escalated while in the above area. During the encounter, gunfire was exchanged before the parties left the area in separate vehicles. The injured man was driven to an area hospital where he later died. No additional injuries or property damage were reported. **This incident does not appear random.** Detectives are actively investigating the incident to determine what led up to the shooting. Commercial Burglary – On January 14 at 12:32AM, officers responded to the Tobacco King located at 2898 Dale Blvd. in Woodbridge (22193) to investigate an alarm activation. The investigation revealed forced entry was made into the building at approximately 12:24AM. Cameras showed two masked individuals enter the business after a rock was thrown through the front glass window. The two suspects and a third masked suspect who remained outside the business a left in a blue Kia sedan.

Residential Burglary – On January 13 at 6:05PM, officers responded to a residence located in the 5000 block of Leatherback Rd. in Woodbridge (22193) to investigate a burglary. The investigation revealed forced entry was made into the home through a basement window sometime between 6:15AM and 5:15PM. Jewelry and an undisclosed amount of money were reported missing.

Malicious Wounding [Domestic] – On January 13 at 9:15AM, officers responded to Elevations One Apartments located in the 14300 block of Jeffries Rd. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 25-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated inside a vacant apartment. During the encounter, the accused struck the victim in the head with a rock before the parties separated. Minor injuries were reported. The accused was also found in possession of a suspected illegal drugs and had been previously trespassed from the property. Following the investigation, the accused, identified as Zaire Tuncay **EZRELL**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On January 13 at 6:35PM, officers responded to the Sleep Inn located at 14080 Shoppers Best Way in Woodbridge (22192) for a person in crisis. Officers attempted to detain the accused for evaluation when she actively resisted, scratching one officer and biting a second officer. The accused was eventually detained without further incident. Minor injuries were reported by the officers. Following the investigation, the accused, identified as Antoinette **GREENE**, was arrested.
