Incidents

Fatal Crash Investigation – On January 17 at 3:41PM, a motor vehicle crash was reported in the area of Centreville Rd. near Breeden Ave. in Manassas (20110). Members of the Crash Investigation Unit were called to the scene to investigate the crash. The investigation revealed the driver of a 2019 Jeep Cherokee was traveling southbound on Centreville Rd. and the rider of a 2024 Suzuki motorcycle was traveling northbound. The driver of the Jeep Cherokee initiated a left turn across the northbound lanes of Centreville Rd and the vehicles collided. The rider and motorcycle separated after impact, and the rider was pronounced deceased at the scene. The driver of the Jeep Cherokee was treated for minor injuries. **Crash investigators are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

Identified:

The deceased rider of the 2024 Suzuki motorcycle was identified as Nicholas Blaze **DAMON**, 25, of Fairfax

The driver of the 2019 Jeep Cherokee was identified as a **44-year-old woman** of Woodbridge

Armed Robbery – On January 18 at 3:49AM, officers responded to investigate a robbery that was reported to have occurred in the 14400 block of Whisperwood Ct. in Dumfries (22025) earlier that morning. The investigation revealed the victim, a 16-year-old male juvenile, was walking in the above area when he was approached by the driver of a vehicle. During the encounter, the driver and another unknown man brandished firearms before demanding the victim's property. One of the suspects struck the victim with the firearm and took his shoes before both suspects left in a white sedan. The victim was treated at an area hospital where police were contacted. The suspects were described as males, possibly juveniles, wearing dark-colored clothing.

Commercial Burglary – On January 18 at 9:34AM, officers responded to Bella Vita Restaurant located at 9675 Liberia Ave. in Manassas (20110) to investigate a burglary. The investigation revealed forced entry was made into the building around 2:48AM. Cameras showed two unknown men wearing masks and dark-colored clothing pry open the rear door to gain entry into the business. An undisclosed amount of money was reported missing. No further suspect descriptions are available at this time.

Attempted and Residential Burglaries – On January 17 at 9:55PM, officers responded to a residence located in the 10000 block of Greenwich Wood Dr. in Nokesville (20181) to investigate a burglary. The investigation revealed sometime between December 14, 2024 and January 17, 2025, forced entry was made into the home through a basement window that was found damaged. No property was reported missing. While investigating the incident, officers determined earlier that evening, there was an attempted burglary at a nearby home in the 10000 block of Hopkins Ln. where a rear basement window was tampered with. No entry was made into the home, and no property was reported missing.

Arrests

Malicious Wounding [Domestic] – On January 18 at 6:59PM, officers responded to The Landings at Markham Grant Apartments located in the 15700 block of Tassleford Ln. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 61-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter the accused retrieved a knife. Another family member, a 19-year-old man, attempted to intervene when he was cut during the encounter. The accused also cut the initial victim before the parties were separated. Both victims were treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as a **12-year-old girl**, was arrested.
