2024 Proposed Work Plan / Monthly Meeting Targets / Accomplishments

2024 Trails and Blueways Goals and Progress Summary

- 1. Explore, collect, and warehouse information about existing community trails and other "low-hanging fruit" that could be added to the county trail system without significant costs or effort. Find ways to utilize volunteers to make some of these realities. (A comprehensive county-wide trails plan, unconstrained)
 - RED Some progress being made though not very visible to T&BC
- 2. Interface with other groups to connect our trails and planned trails to Fairfax County, Stafford County, Loudoun County, and the National Capital Region.
 - YELLOW Conversations with Stafford County, Fairfax County and National Capital Region but limited follow-up
- 3. Encourage volunteer efforts for maintaining more PWC trails using new PWC approved methodology.
 - YELLOW Volunteer program put in place; MORE and Trails Keepers making progress; need more integration with #1
- 4. Support and encourage PWC CIP additions for trails outside of bonds and additional trail maintenance funds.
 - GREEN Recurring \$1M for trails added in 2024 need much more to reach 2040 comprehensive plan goals.
- 5. Finish arranging plans and approaches for gaps in PHNST. Establish a traceable schedule to track in future years completing in 2031.
 - YELLOW Approaches worked throughout year. GAP Study Delays limited progress on three major gaps. Need to establish alignments and get BOCS, DPR, NVRC, PHNST and anybody else in sync with one set of routes. Given up on a detailed schedule.
- 6. Encourage and track changes and updates to the Occoquan Greenway culminating in completion of this route from McCoart to Occoquan in 2025.
 - YELLOW Two bridges added in 2024. Ellicott Road upgrade will not finish before 2026. Progress continues. No progress reported on section from McCoart to Lake Ridge Golf Course.
- 7. Inventory and identify gaps and approaches toward completion of the Broad Run Greenway.
 - YELLOW Reported at several meetings. Progress being made on some gaps.
- 8. Inventory and identify gaps and approaches toward completion of the Neabsco Creek Greenway.
 - YELLOW Reported at several meetings. Metz boardwalk partial completion started.
- Inventory and identify gaps and approaches toward completion of the Catharpin Creek Greenway.
 - YELLOW Reported at several meetings. Some progress being made.
- 10. Inventory and identify gaps and approaches toward completion of the Powells Creek Greenway.
 - RED Reported at several meetings. Only progress is at Powell's Creek crossing. Many other areas could advance based on social trails.
- 11. Inventory and identify gaps and approaches toward completion of a Bull Run Loop trail in concert with Fairfax County.

- YELLOW Reported at several meetings. Part of VRE Trail by Rail grant application. Added to Legislative agenda
- 12. Develop maps, plans, and approaches for one or more blueways in the county.
 - GREEN Initial Survey completed and documented. Boat launch being built at Neabsco Boardwalk. Two sites part of Doves Landing design underway. Other sites being pushed.
- 13. Develop two prioritized lists for each district of recreational trails and bike/pedestrian trails. Get buy-in from each district's supervisor for the list.
 - GREEN Completed as part of CIP funding exercise. Smaller list sent to Supervisors for 2025 CIP. Manage lists in 2025
- 14. Encourage at least one trails or blueways ribbon cutting in each district.
 - YELLOW Multiple in Coles. Some in other districts. Need more parks/trail projects underway to have more of these.
- 15. Publicity / awareness of the TBC and its work
 - YELLOW T&BC presence at parks and trails events; t-shirts provided need name tags when t-shirts not appropriate. Still need more exposure.
- 16. Communication plan to keep Supervisors updated formalize
 - GREEN General discussions took place on best approaches and left to each member to interact with supervisors and their chief of staff. Parks emails to each district started are of good value.
- 17. Get more representation from the Potomac District especially since the potential for a park at Cockpit Point is coming closer
 - GREEN Filled this position twice over the course of 2024. Welcome to Kimberly.
- 18. More signage / standardized signage
 - RED Very little progress on this. Recommended mileage and wayfinding painting on shared use paths.
- 19. Boat launch at Sinclair Mill site (with different language)
 - YELLOW Part of Dove Landing design work progress report in January. Need focus on Long Branch crossing by developer prior to handoff of Preserve at Long Branch and Sinclair Mill sites to DPR.
- 20. Inventory and identify gaps and approaches toward completion of the Cannon Branch Greenway
- YELLOW Added late in year as connection to Manassas City trails and Broad Run Greenway. Expect something in December.

Call to Order

The meeting was called to order by Liz at 6:30 PM.

Pledge of Allegiance

Administrative:

 November 19th T&BC minutes were approved through a motion by Lynda and seconded by Steven.

- Kimberly Palacios was introduced as the new Potomac District T&BC member. She talked about being in PWC for the past 5 years and her interest in Quantico Creek and its Greenway.
- No new office nominations were received for 2025 positions. A motion by Bill and seconded by Duane to elect the three nominees was passed unanimously. The 2025 officers will be
 - Chair Liz Cronauer
 - o Vice Chair Catherine O'Connor
 - Secretary Neil Nelson
- 2025 Meeting Dates were accepted unanimously on a motion from Bill and seconded by Duane. Dates selected are 1/28, 2/25, 3/25, 4/22, 5/27, 6/24, 7/22, 8/26, 9/23, 10/28, 11/18 and 12/16.
- Robert Boyd will update member contact information on the website and create a new list for T&BC members to use.
- New T&BC members are eligible to receive a T&BC Shirt. Please contact Janet with your size.
- Liz discussed a review of T&BC bylaws and asked everyone to review them and submit to Janet any potential changes. It was asked when we will update our rules to match the latest state direction on virtual access to meetings. We have to wait until such changes are rolled out to the BOCS and then we can copy their procedures.

Citizen's Time.

 Russell Bryant thanked DPR for their work on the Neabsco Boardwalk boat launch and Blackburn ADA parking. He recommended that T&BC members talk to their supervisors to reprogram the \$200M for the sports center toward parks and trails.

County Agency Representatives

PWC Department of Parks and Recreation (DPR). Seth Hendler-Voss, Janet Bartnik, Patti Pakkala, David Kroeger, Robert Boyd

- DPR Director Seth Hendler-Voss attended the T&BC meeting and thanked the T&BC for their active role in engaging, advocating and sharing information that has led to tangible results. He singled out Janet for her attention and steady leadership leading to the DPR making more progress, generating interest from the BOCS and gaining board approvals. Their recent focus has been on completing 2019 Bond projects on time. He would like to get more western county trails funded and grow popular programs to meet demand. When asked about our challenges with landfill trails and their new management, he said he expects these will be worked out together. He was also questioned about the PHNST and Cockpit Point which caused him to mention the need for sustainable funding for parks and trails where he hoped the T&BC could continue to advocate.
- Seth announced that the State of the Parks community meeting will be held January 30th at Colgan High School which he hopes will have more casual users present.
- David reported:
 - Planning staff is mapping county trails with high-accuracy GPS as part of the trails Master Plan update. In addition, staff is photographing and collect data on trail access points, trail amenities, trail signage, and trail crossings. David expects it to take 4-6 months, and it will include some social trails. T&BC members are welcome to contact David to accompany him on any of his "hikes" collecting data.
 - The GIS analyst position will be open until December 23. We encourage members to share this information.

- PHNST Gap Study. We hope to have the next and final stakeholder meetings in early February.
- Occoquan Greenway. Segment 2 bridge replacement is complete.
- Staff continue to finalize grant documents for the extension of the boardwalk at Metz
 Wetlands Bank. They hope to begin construction by next summer.
- Staff continue to work on equestrian trail improvements at Valley View Park this work
 will include parking lot improvements and a new trail segment from the parking lot.

PHNST Subcommittee Work Session Notes January 22, 2025, at 2:00pm Hellwig Administration Building 14420 Bristow Road, Manassas

1. Call to Order – David Brickley, Eileen Sheridan, Neil Nelson, Joe Marshall, Kimberly Palacios, and Liz Cronauer were present. Staff present – Yolanda Hipski, Janet Bartnik, David Kroeger, and Robert Boyd.

2. PHNST Gap Analysis Notes

Gaps 19 & 20:

David Brickley shared a letter he had written to ask a homeowner to consider meeting with him about the PHNST alignment near 123 & 95. No response has been received. The group discussed options for alignments remaining.

Keeping the trail along 123 is not scenic and involves high speed traffic. Occoquan Road was suggested as a preferable alignment to 123. In the 123/95 improvements VDOT is reviewing, it was noted that to get to the park & ride, a pedestrian must traverse a grade change.

The consultant is reviewing the interchange improvements as a part of the Gap Study. Discussion of a future Rt. 1 crossing of the Occoquan is not likely to be considered a PHNST segment by Fairfax, as that is NOVA Parks. For long range planning purposes, PWC could push for an alignment east along the river in Fairfax to an eastern crossing near Belmont.

PWC could consider how to create a destination for cyclists in north Woodbridge in the area of the North Woodbridge small area plan. Could the commuter lot be used as a trailhead on weekends?

Destination Place developer indicated that they were following the comp plan (sidewalks) at the civic association community meeting. Suggested that we consider being careful about which lines we show on the comp plan map so that we can best direct developers.

Destination Place's property has much land that is not buildable (RPA). Latest revision of the development plan includes a proffer proposal to dedicate a 20' easement with the condition that the County build the trail within 20 years. Comments are being crafted now. They will be reviewed by the planning office reviewer and county attorney's office.

The Gap Study preliminary report is due for public review February 12 at 1pm. This is an opportunity to give feedback on findings. It is intended that the final report delivered in April will be the most feasible route as the situation is today, and the final alignment could be something different depending on how conditions change over time.

Belmont Bay:

The development proposed appears to be moving forward as planned.

Featherstone:

The project is moving along, although stalled for weather and a delay in signing on a bridge manufacturer. Staff is working through the bridge issue. There is a small gap between the end of the Featherstone trail and the VRE station through the gas easement to the VRE station ramp. Staff is working through that issue.

Metz Wetland Boardwalk Extension:

In review with the state prior to bid advertisement.

Powell's Creek Crossing:

Concept C2 of the crossing was selected. Next steps for the project were shared with the group. More info will be shared once the BOCS Chair has been briefed.

Potomac Shores:

No construction yet on the developer's side. Staff provided review comments on the site plan submitted by the developer. Staff is working with the developer through the Powell's Creek Crossing project.

Inform consultant is working with Potomac Shores on the approach to the Crossing. Planning team staff is involved in the work on the proffered subdivision trails, including the potential for an extra connection to the overlook not included in the original plans.

Dumfries Gaps:

Robert sent Liz a link to add input into the comp plan feedback portal for the Town of Dumfries before the link expired.

Joe Marshall connected with the National Parks Conservation Alliance (NPCA) about the architectural study needed for the W-R Route in the national park. It was suggested that we connect with Vindman.

Gap Study findings and preliminary report due for public review February 20 at 1pm.

A meeting for staff has been scheduled in late February for the Town, County, and Dominion to share updates on various projects in the Dumfries area. The goal is to ensure coordination and seamless project delivery.

WHEREAS, The Trails and Blueways Council passed Resolution No. 23-3 in May of 2023 with recommendations for improvements to the design of a proposed shared use path along the proposed Route 28 Bypass in Flat Branch Stream Valley between Sudley Road and Bull Run, and

WHEREAS, The Prince William County Department of Transportation has been requested to draft a motion to cancel the Route 28 Bypass project which would result in approximately \$92,392,000 in transportation funding made available to other projects, and

WHEREAS, The Prince William County Trails Plan, which was adopted by the Board in the Mobility Chapter of the 2040 Comprehensive Plan, includes a Greenway with a trail in the Flat Branch Stream Valley in the area where the road was to be built, and

WHEREAS, The City of Manassas plans to construct a bike trail along Godwin Blvd ending at Sudley Road (its boundary with Prince William County) providing connectivity to many city destinations, and

WHEREAS, The construction of a stream valley trail in Flat Branch between Sudley Road and Bull Run Regional Park would provide numerous benefits to the people who live in the nearby neighborhoods, which include equity emphasis areas, and

WHEREAS, Those benefits include access to healthful passive recreation opportunities for hiking and cycling in wooded and open spaces, for residents in the vicinity and,

WHEREAS, Those benefits also include bike and pedestrian access between the various neighborhoods as well as access to the athletic fields and trails at Ben Lomond Regional Park, Fairmont Park, Manassas and Manassas Park destinations, the facilities at Splash Down Water Park, and the Bull Run Greenway Trail, which will connect from Ben Lomond to the Manassas Battlefield Park as well as future connections to trails on the Fairfax county side of Bull Run, and

WHEREAS, Some social trails already exist in the area and these could be opened quickly until a larger, more complete project can go through design and construction,

NOW, THEREFORE, BE IT RESOLVED that, in the event that the Board chooses to cancel the Route 28 Bypass project, the Trails and Blueways Council recommends that the Board allocate sufficient funding from the Route 28 Bypass budget for design and construction of the Flat Branch Greenway Trail and all necessary supporting infrastructure to provide connections to adjacent neighborhoods and park facilities between Sudley Road and Bull Run, and ultimately transfer affected State-owned right of way property currently targeting the Route 28 Bypass to the Department of Parks and Recreation.

GOAL: Plan the Trails and Blueways System

2025 ACTIONS:

- 1. Develop the comprehensive County-Wide Trails Master Plan prescribed in the Prince William County 2040 Comprehensive Plan including examination of possible for trail connections for areas that are designated for significant residential development or for transportation-oriented improvements.
- 2. Explore, collect, and warehouse information about existing community trails and other "low-hanging fruit" that could be added to the county trail system without significant costs or effort. Find ways to utilize volunteers to make some of these realities.
- 3. Finish arranging plans and approaches for gaps in PHNST. Establish alignments and get BOCS, DPR, NVRC, PHNST and other stakeholders in sync with one set of routes. Special focus on the Occoquan to Belmont Bay gap, the Dumfries Quantico Creek gap and Greenway and the PWFP to Locust Shade Park gap
- 4. Work toward standardized signage both on recreational and bike-ped trails.

GOAL: Advocate for Trails Funding and Support

2025 ACTIONS:

- 5. Maintain two prioritized lists for each district of recreational trails/blueways and bike/pedestrian/equestrian trails. One list for CIP projects and another for smaller, short term projects to be used for funding prioritization.
- Support and encourage PWC CIP additions for trails outside of bonds and additional trail maintenance funds. Look for other funding opportunities. Work for at least \$5M in trail maintenance/improvement funding for FY2026.
- 7. Attend presentations to the BOCS at public meetings as appropriate
- 8. Insert T&BC bike-ped concerns and rec trail connections as appropriate into Transportation Road designs throughout the concept and early design process.
- Advocate for completing missing sections and updating of recreational trails, shared use path connects
 and blueway elements in the Parks and Open Space Master Plan in the Mobility Section of the County
 Comprehensive Plan while it is being updated to include elements from the County Sustainability Plan.
- 10. Stay abreast of, evaluate, and provide information as appropriate, to Supervisors on rezonings for trail and blueway concerns.
- 11. Encourage TBC members to attend BOCS work sessions and hearings to advocate for increased trails and blueways funding.
- 12. Create an onboarding package for new members

GOAL: Increase Awareness and Engage the Community

2025 ACTIONS:

- 13. Interface and collaborate with other groups including PWC advisory bodies (e.g. Parks and Recreation Commission) and citizen groups (e.g. GWPTC, Active PW, PWTSC, East Coast Greenway) to connect our trails and planned trails (e.g. PHNST, Bull Run Loop, I-66 Trail, VRE Trail by Rail) to Manassas, Manassas Park, Dumfries, Haymarket, Occoquan, Fairfax County, Stafford County, Loudoun County, and the National Capital Region.
- 14. Encourage at least one trails or blueways ribbon cutting in each district, e.g. Neabsco Boardwalk Kayak Launch Site

- 15. Publicity / awareness of the TBC and its work including magnetic nametags for all members and occasional exposure on DPR social media
