

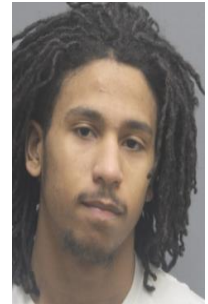


## DAILY INCIDENT REPORT

February 24, 2025

### Incidents

**Felony Hit & Run Investigation** – On February 2 at 9:00PM, officers in the 1400 block of Admiral Dr. in Woodbridge (22192) attempted contact with the occupants of a stolen vehicle. During the encounter, the driver of the vehicle, later identified as the accused, reversed the vehicle and struck an occupied police vehicle before fleeing the area. No injuries were reported. Additionally, two female juveniles who had initially ran from the vehicle were detained by Occoquan police and released to the custody of known parties. Following the investigation, officers obtained arrest warrants for the accused, identified as Timothy Damon **RUTHERFORD**. Attempts to locate the accused have been unsuccessful.

**Reckless Handling of a Firearm** – On February 24 at 12:38AM, officers responded to the area of Oakwood Dr. near Dulcinea Pl. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed multiple shots were fired into the air from a dark-colored sedan that left the area. No injuries or property damage were reported.

**Indecent Exposure** – On February 22 at 9:43AM, officers responded to the intersection of Richmond Hwy. and American Eagle Blvd. in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed an unknown man exited a dark-colored older model SUV before he walked behind a tree where he then exposed himself and made inappropriate gestures. No physical contact occurred, and the suspect left prior to police arriving in the area. The suspect was described as a Hispanic male, approximately 30 years old, with a top bun, last seen wearing a dark-colored jacket and jeans.

**Attempted Residential Burglary** – On February 23 at 6:41PM, officers responded to a residence located in the 16900 block of Monmouth Ct. in Dumfries (22026) to investigate an attempted burglary. The investigation revealed sometime between January 13 and February 23, entry was attempted into the home through a window that was found tampered with. No entry was made into the home, and no property was reported missing.

## Arrests

**Sexual Assault Investigation** – On February 20, 2025, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence in the Gainesville (20155) area of Prince William County on December 22, 2024. The investigation revealed the victim, an adult woman, was hosting a gathering at her home when she became incapacitated. While incapacitated, another attendee of the get-together, later identified as the accused, sexually assaulted the victim. On February 20, following the investigation, detectives obtained charges against the accused, identified as a **16-year-old male juvenile**, who turned himself into police without incident.

**Felony Child Neglect** – On February 21 at 3:40PM, officers responded to Walmart located at 17041 Richmond Hwy. in Dumfries (22026) to investigate an unattended child. The investigation revealed the accused left her 2-year-old son unattended inside her vehicle while she shopped inside the store. Officers responded to the parking lot when a Good Samaritan observed the child inside the vehicle unsupervised. While investigating the incident, the accused returned to the vehicle. When officers attempted to detain the accused, she briefly resisted before being detained without further incident. The child did not appear injured and was released to the custody of known parties. Following the investigation, the accused, identified as Tasha Michelle **OSEI-ASIBEY**, was arrested.
