**Felony Hit & Run Investigation \*ARREST** - On February 27, the suspect sought in connection to the felony hit and run that was reported to have occurred in the 1400 block of Admiral Dr. in Woodbridge (22192) on February 2, was arrested. The accused, identified as Timothy Damon **RUTHERFORD**, was apprehended in Bulloch County, Georgia where he will be held until extradited to Prince William County.

**Felony Hit & Run Investigation [Previously Released]** - On February 2 at 9:00PM, officers in the 1400 block of Admiral Dr. in Woodbridge (22192) attempted contact with the occupants of a stolen vehicle. During the encounter, the driver of the vehicle, later identified as the accused, reversed the vehicle and struck an occupied police vehicle before fleeing the area. No injuries were reported. Additionally, two female juveniles who had initially ran from the vehicle were detained by Occoquan police and released to the custody of known parties. Following the investigation, officers obtained arrest warrants for the accused, identified as Timothy Damon **RUTHERFORD**. Attempts to locate the accused have been unsuccessful.

## Incidents

**Malicious Wounding** – On February 26 at 10:39AM, officers responded to the 16600 block of River Ridge Blvd. in Woodbridge (22191) to investigate an assault. The investigation revealed a tow operator was in the process of repossessing a vehicle when he was confronted by the owner, identified as the accused. During the encounter, the accused struck and bit the operator before the parties separated and the accused left the area. Later that morning, in the 13600 block of Richmond Hwy., the accused approached the operator a second time and struck him in the face, breaking his glasses. The accused left the area prior to police arriving on scene. The victim reported non-life threatening injuries from both incidents. Following the investigation, officers obtained arrest warrants for the accused, identified as Dorell Montea **FARMER**. Attempts to locate the accused have been unsuccessful.

**Armed Robbery** – On February 26 at 8:20PM, officers responded to the Coverstone 4 Apartments located in the 7600 block of Mangione Ct. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 15-year-old male juvenile, arranged to sell a Sp5der sweatshirt to an unknown individual via Instagram. The victim and an adult family member met with the buyer and two unknown individuals in the above area where the clothing was taken. At one point, a firearm was brandished before the parties separated. No injuries were reported.

**Armed Robbery** – On February 26 at 3:39PM, officers responded to the 8100 block of Community Dr. in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, was approached from behind by a masked individual, possibly a juvenile. During the encounter, the suspect brandished a firearm before taking a pair of Balenciaga shoes and dispersing. No injuries were reported.

## Arrests

**Malicious Wounding [Domestic]** – On February 24 at 11:01PM, officers responded to investigate a domestic dispute that was reported to have occurred in the 7800 block of Amherst Dr. in Manassas (20111) in March 2022. The investigation revealed the victim, a 41-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times while she was driving a vehicle. The parties eventually separated, and the victim reported non-life threatening injuries from the incident. Following the investigation, officers obtained arrest warrants for the accused, identified as Gustavo **TERRAZAS ESCOBAR**, who was arrested in Fairfax County on February 26.

**Strong-Arm Robbery** – On February 25, officers concluded an investigation into a robbery that was reported to have occurred between two students at Woodbridge High School located at 3001 Old Bridge Rd. in Woodbridge (22192) on February 13. The investigation revealed the victim, a 14-year-old male juvenile, was approached by another student, identified as the accused, while in a school restroom. During the encounter, the accused assaulted the victim and took his property before leaving the restroom. The victim reported non-life threatening injuries from the incident. Following the investigation, the accused, identified as a **17-year-old male student**, was arrested.
