Malicious Wounding [Previously Released] - On February 26 at 10:39AM, officers responded to the 16600 block of River Ridge Blvd. in Woodbridge (22191) to investigate an assault. The investigation revealed a tow operator was in the process of repossessing a vehicle when he was confronted by the owner, identified as the accused. During the encounter, the accused struck and bit the operator before the parties separated and the accused left the area. Later that morning, in the 13600 block of Richmond Hwy., the accused approached the operator a second time and struck him in the face, breaking his glasses. The accused left the area prior to police arriving on scene. The victim reported non-life threatening injuries from both incidents. Following the investigation, officers obtained arrest warrants for the accused, identified as Dorrell Montea FARMER. Attempts to locate the accused have been unsuccessful.
