## **Incidents**

**Fatal Crash Investigation** – On February 25 at 2:33PM, crash investigators responded to the area of Pageland Ln. near Livia Dr. in Catharpin (20143) to investigate a crash. The investigation revealed the driver of a 2014 Nissan Versa was traveling southbound on Pageland Ln. above the posted speed limit when the vehicle crossed into oncoming traffic, striking a 2020 Mercedes Benz GLC 300 traveling the opposite direction. The Mercedes then left the roadway and came to rest in the ditch. The driver of the Nissan was not wearing a seatbelt at the time of the collision and was transported to an area hospital where he later died. The driver of the Mercedes was transported to an area hospital for non-life threatening injuries. The investigation continues.

The deceased driver of the 2014 Nissan Versa was identified as Nathaniel Marcelo **DELGADO**, 24, of Bristow

The driver of the 2020 Mercedes Benz GLC 300 was identified as a 47-year-old woman of Chantilly

**Armed Robbery -** On February 25 at 11:30PM, officers responded to CVS located at 16712 Richmond Hwy. in Dumfries (22172) to investigate a robbery. The investigation revealed an unknown man brandished a firearm while demanding money from the employees at the service counter. The suspect left with an undisclosed amount of money. No injuries were reported. Officers and a police K-9 searched the area for the suspect who was not located.

### **Arrests**

**Possession with Intent to Distribute –** On February 19 at 12:06PM, the School Resource Officer (SRO) assigned to Hylton High School located at 14051 Spriggs Rd. in Woodbridge (22193) was notified of two students who were distributing candy bars containing a controlled substance on school grounds. The investigation revealed two students, identified as the two accused, sold the candy bars suspected of contacting psilocybin mushrooms to another student on February 14. A student who purchased the candy bars was found in possession of the bars by a parent who contacted the school and notified the police. The SRO determined the students brought the candy bars to school for the purpose of distributing them to other students. Following the investigation, the two accused, identified as a **17-year-old female juvenile** and a **17-year-old male juvenile** were charged.
